#### **COMMISSION ADOPTION ORDER**

By this **ORDER**, the California Energy Commission adopts as its own Decision the October 26, 2018 Proposed Decision,<sup>1</sup> which was issued by the Committee assigned to the above-captioned matter, and the Errata dated November 6, 2018.<sup>2</sup> The Decision addresses the Application for a Small Power Plant Exemption filed by Vantage Data Centers for the McLaren Backup Generating Facility Project. The Decision is based upon the hearing record of these proceedings.

#### **FINDINGS**

The California Energy Commission finds as follows:

- 1. The McLaren Backup Generating Facility will not generate electricity in excess of 100 megawatts.
- 2. The construction and operation of the McLaren Backup Generating Facility will not create a substantial adverse impact on the environment.
- 3. The construction and operation of the McLaren Backup Generating Facility will not create a substantial adverse impact on energy resources.

#### ORDER

The California Energy Commission **GRANTS** the McLaren Backup Generating Facility Project a Small Power Plant Exemption from the Application for Certification provisions of the Commission's power plant licensing process.<sup>3</sup> The Hearing and Policy Unit shall incorporate the McLaren Backup Generating Facility Project Committee Proposed Decision, Errata, and any modifications made by the Commission during the November 7, 2018, Business Meeting into a single document.
