PG&E Planning Area

Manufacturing Output	2.79%	2.65%
Commercial Employment	0.82%	0.61%

- Baseline Consumption continues sees continued growth driven by residential sector
- Baseline Sales growth declines slightly growing at 0.76% leading to continued decline in managed sales growth



PG&E Consumption


- Baseline total consumption grows at slightly higher at 1.35% driven by residential sector
- Per capita income remains strong along with increasing persons per household

- Baseline Consumption growth is unchanged at 1.3%
- Baseline Sales also remains close to CED 2017 at 0.85%



SCE Consumption


- Increasing persons per household drives residential consumption while commercial consumption declines due decrease in commercial employment
- Growth remains the same at 1.3%

SCE Managed Sales

- Similar consumption along with no change in PV results in baseline sales growth matching 2017 at 0.85%
- Managed sales grows at -0.3% annually

- Baseline Consumption increased slightly in the residential sector but is matched by commercial sector decline
- Baseline Sales is primarily affected by changes to PV forecast given similar consumption projection


- Total consumption grows at 1.5% nearly matching 2017
- Residential sector sees increased growth while the commercial sector declines
- Decreasing commercial employment is driving the reduction in commercial sector



LADWP Managed Sales


- Baseline sales grows at slightly slower 1.2%;
- Less decline in persons per household relative to 2017 helps drive residential consumption





LADWP Managed Peak

- Baseline peak demand grows at 1.3% slightly higher than
 2017
- Residential consumption increase drives peak demand





SMUD Planning Area



- Baseline Energy sales growth reduced by .21% annually
- Baseline Peak growth decreased slightly and remains flat



SMUD Managed Sales


Higher starting point but slower growth at 1.4% due to decreases in commercial sector consumption and sales

- Baseline peak demand grows at 1.2%
- Residential consumption which saw little decline
