- 3 COMMISSIONER SCOTT: Hello everyone and
- 4 good afternoon. We're just waiting for our court
- 5 reporter to finish getting all the recording
- 6 devices set up and then we will get started.
- 7 Hold on just one more moment, please.
- 8 (Pause)
- 9 COMMISSIONER SCOTT: Okay, we are good to
- 10 go. So, let's go on the record, please.
- 11 Good afternoon, everyone. I'm
- 12 Commissioner Janea Scott. I'm the Presiding
- 13 Member for the Puente Power Project AFC. This is
- 14 a Committee Conference being held primarily for
- 15 the purposes of holding a closed session.
- 16 I'm joined here with my Advisor, Matt

- 4 there.
- 5 MR. PINJUV: Yes, Jordan Pinjuv here for
- 6 the ISO.
- 7 COMMISSIONER SCOTT: Hi, good afternoon.
- 8 Do I have anyone from the California
- 9 Coastal Commission, the U.S. Geological Survey?
- 10 If so, please say hello and introduce yourself.
- Okay, and do I have anyone from any
- 12 Tribal, Federal, State, or Local Governmental
- 13 agencies? If so, please introduce yourself?
- Okay, everyone is unmuted and hearing
- 15 none. I would also like to introduce to you our
- 16 Public Adviser, Rosemary Avalos. Hello.
- MS. AVALOS: Hello.
- 18 COMMISSIONER SCOTT: And with that, I
- 19 will now turn this over to our Hearing Officer,
- 20 Paul Kramer.
- 21 HEARING OFFICER KRAMER: Okay, thank you.

- 2 session, since the status of this proceeding is
- 3 in suspension.
- 4 And all we're doing is cleaning up a few
- 5 things on the Committee's behalf before we
- 6 basically go into suspended status, as well.
- 7 So, again, nothing is expected to be
- 8 reported out, but you're welcome to come back at
- 9 4:00 o'clock. And if we take a little bit longer
- 10 it will be after that, but it will not be any
- 11 earlier.
- 12 So, with that we are adjourned to a
