**PETITION FOR CHANGE OF OPERATIONAL CONTROL for the**  
**Henrietta Peaker Power Plant (01-AFC-18C)**

On February 1, 2019, MRP San Joaquin Energy, LLC, filed a petition with the California Energy Commission (Energy Commission) requesting to transfer operational control for the Henrietta Peaker Power Plant (HPPP) from AltaGas Tracy Operations, Inc., to MRP San Joaquin Energy LLC. The simple-cycle, natural gas-fired, 95-megawatt facility was certified by the Energy Commission in its Decision on January 31, 2002, and began commercial operation on July 1, 2002. The facility is located approximately one-mile south of Highway 198 on 25<sup>th</sup> Avenue southeast of the City of Lemoore in Kings County.

The request would transfer responsibility for compliance with conditions of certification to MRP San Joaquin Energy, LLC. A statement describing the change in operational control, signed under penalty of perjury by a representative of MRP San Joaquin Energy, LLC, was submitted as required by Title 20, California Code of Regulations, section 1769(b)(2). The statement affirms that the new owner agrees to be bound by the requirements of the Energy Commission's Decision for the project and understands the obligations imposed by the conditions of certification. The Energy Commission may approve changes of operational control after a 14-day public notice.

This Notice of Receipt is being mailed to interested parties and property owners adjacent to the facility site who may want to submit comments.
