



# **SMUD IRP and Carbon Goals**

- IRP Tradeoff- further increasing renewable investments vs focus on transportation and building decarbonization
- Board chose more expensive local investment in T+B decarbonization, committing \$1.7B over next 20 years to these initiatives

Single Family New Construction	79	194	Commitments from 4 of the top 25 builders in Sacramento, Much more interest this year, 230 commitments 2020-2021
Multifamily New Construction	0	18	Main issue is both lead time for multifamily as well as central HPWH systems are challenging to electrify
HP-HVAC Equipment	134	500	Predominantly HPP so far, launching Equipment Efficiency in June
HPWH Equipment	142	654	Delivery through HPP and Equip Eff, seeing some organization around HPWH
Induction Cooking	10	20	Multiple challenges – emotional choice for consumers, delivery method of program as well
Multifamily Existing	88	300	Aided by our internal low income programs as well as external low income programs (multiple funding sources)
