Pursuant to the California Code of Regulations, Title 20, Article 2, Section 1342, Southern California Edison Company (SCE) respectfully requests an extension of time to submit Electricity Demand Forecast Form 1.6a (Form 1.6a). Information about Form 1.6a was specified in the CEC Staff Final Report "Forms and Instructions for Submitting Electricity Demand Forecasts" that was docketed on January 7, 2019.

SCE respectfully requests a second extension for submitting Form 1.6a. SCE is currently migrating its load data to a new data platform and therefore faces challenges in obtaining hourly, historical Direct Access (DA) and Community Choice Aggregation (CCA) data. SCE had at first requested a fifteen-day (15) extension of the filing deadline for submitting Form 1.6a and received approval from the CEC granting extension on April 12, 2019. However, SCE has identified data issues that will take additional time for SCE to resolve. SCE is requesting an additional extension until **May 15, 2019**, when it will re-submit all of Form 1.6a with the hourly historical DA and CCA data included.


