We must have a balanced approach with policies that limit the negative impact on business and residents alike. We ask you to develop decarbonization policies that rely not only on electricity, but also on renewable natural gas, hydrogen, and fuel cells.

We are very concerned your action plan will heighten security threats to society, limit reliable back up options and could exacerbate the effect of natural disasters. In our community, wild fires have been started by electrical power lines, causing not only loss of homes, wild life and business, but of lives. Home owner insurance has risen substantially in our community due to these wild fires, your policy is risking our community's ability to rebuild and recover.
