Dear California Energy Commission,

If we are serious about curbing the acceleration of climate change, we must stop depending on natural gas, no matter how "cheap." The supposed cheapness of natural gas does not account for the future havoc that catastrophic climate change will wreak on everything from infrastructure, to water supply, to wildfires.

Dear Commissioner:

California has already pledged to generate all of its electricity through clean renewable energy by 2045. A quarter of California's greenhouse gas emissions are from homes and buildings, the majority of which come from onsite combustion of methane gas for heating. To meet its climate goals, the state must phase out the use of gas in our homes and buildings entirely.

California cannot afford to slow down its pace in transitioning from dirty methane gas to clean electricity in homes and buildings. Clean alternatives, such as solar and wind, are ready and are California's best hope for avoiding more devastating climate impacts.

I strongly encourage the Energy Commission to stay on track with California's climate targets and work towards phasing out gas entirely and rapidly.
