LAURELWOOD DATA CENTER STATUS REPORT #1

In accordance with the *Committee Scheduling Order* docketed on May 31, 2019,¹ MECP1 Santa Clara 1, LLC (the "Applicant") files this Status Report to inform the Committee on the progress of the Laurelwood Data Center ("LDC") application for the small power plant exemption proceeding.

On June 13, 2019, the Applicant docketed an updated Project Description, which describes refinements to the site plan and project as a result of discussions with the City of Santa Clara and in response to data requests from California Energy Commission ("CEC") Staff.

The Applicant is in the process of completing its responses to CEC Staff's Data Request Nos. 16, 17, 25, 26, 31-34, 36, 45 and 48, which requested air quality dispersion modeling, and informal data requests. While the requested air dispersion modeling is not required under the Bay Area Air Quality Management Rules, the Applicant has nevertheless agreed to provide the information as a courtesy. The Applicant expects that the responses will be submitted on or before June 28, 2019.
