Santa Clara Police Department

Energy Commission staff, Ashley Gutierrez, Planner I, communicated with Carolyn McDowell, Staff Analyst for the City of Santa Clara Police Department. Emails were exchanged between March 28 and April 11, 2019. The following is a report of conversation relevant to staff's analysis:

The average response time for priority one calls for service over the past five (5) years has remained fairly consistent:

4:37
4:35
4:07
4:28
4:26

These figures measure the duration of time, from time of dispatch to the time the first officer arrives on scene for priority one calls, only. These figures are not a standard, but are real data regardless of day, time and location throughout the city (including the project site).

Santa Clara Fire Department

Energy Commission staff, Lisa Worrall, Planner II, communicated with Jeremy Ray, Deputy Fire Chief for the City of Santa Clara Fire Department (SCFD). Emails were exchanged between May 3 and May 8, 2019. The following is a report of conversation relevant to staff's analysis:

SCFD has a total of 167.5 fire service personnel, which includes all fire prevention and administrative/clerical staff. The number of sworn emergency responders is 138.

SCFD responds to over 9,000 calls for service annually, with approximately 70 percent of the calls for emergency medical services, 20 percent classified as "other" (fire alarm responses and service calls), 5 percent for injuries (vehicle accidents), 2 percent for fires, 2 percent for hazardous materials, and less than 1 percent for rescue calls.

Based on the city's 2018 estimated population (129,604) and SCFD's current fire personnel roster, the SCFD's firefighter staffing ratio is 1.07 firefighters for every 1,000 residents.
