REVISED NOTICE OF STATUS CONFERENCE AND FURTHER ORDERS

On March 5, 2019, MECP1 Santa Clara 1, LLC (Applicant) submitted an application for a small power plant exemption (SPPE)¹(Application) for the Laurelwood Data Center (Laurelwood or Proposed Project) to the California Energy Commission (Energy Commission).

BACKGROUND

Small Power Plant Exemptions

The Energy Commission is responsible for reviewing, and ultimately approving or denying, the construction and operation of all thermal power plants in California that will generate 50 megawatts (MW) and greater. The Energy Commission may grant an exemption to this authority, and allow an applicant to obtain permission to construct and operate through local jurisdiction review and approval processes, if a project is less than

100 MW and will not result in substantial adverse impacts on the environment or energy resources.³ In making these determinations, the Energy Commission is the "lead agency" under the California Environmental Quality Act (CEQA) and follows the substantive and procedural requirements of that law.⁴

The Laurelwood SPPE

Applicant applied for an SPPE for the proposed Laurelwood Data Center project at 2201 Laurelwood Road, in Santa Clara, California. Laurelwood would consist of two four-story buildings to be operated as a "server farm." The Proposed Project also includes construction of a substation with connections to existing distribution lines with Silicon Valley Power (SVP).

Applicant proposes to install 56 3-MW diesel-fired, back-up generators to provide electricity in the event of an interruption of power delivery from SVP. According to the Application, these back-up generators would have a maximum output of 99 MW, the maximum building load of Laurelwood. One of the generators would be dedicated solely to use for fire suppression and other emergency operations.

CEQA requires the lead agency to consider the whole of the action. Therefore, the Energy Commission will include the entire data center project in its analysis, which includes the construction of two new four-story data center buildings, the substation, the switchyard, and the installation and operation of the generators.

Status of SPPE Proceeding

A Committee Conference was held on May 8, 2019, during which the parties and the public discussed the processing and schedule for the Application.⁵ Applicant indicated that it would be providing a revised project description and additional information to previous data requests⁶ by May 24, 2019.⁷

On May 31, 2019, the Committee issued a Committee Scheduling Order that required, among other things, that the parties file status reports by June 20, 2019, and that Energy Commission Staff (Staff) file its initial study and environmental analysis by July 11, 2019.⁸

On June 13, 2019, Applicant filed an "Updated SPPE Project Description."9

On June 20, 2019, Staff and Applicant filed status reports.¹⁰ In Staff's status report, it anticipated it would propose that the Committee amend its scheduling order because of

delays in receiving requested information.¹¹ Applicant's status report indicated they filed an updated Project Description on June 13, 2019, as a result of discussions with the City of Santa Clara, and expected to submit additional information to Staff on or before June 28, 2019.

On June 21, 2019, Applicant filed a second "Updated SPPE Project Description,"¹² and responses to informal data requests.¹³ On June 27, 2019, Applicant filed additional information responsive to previous data requests.¹⁴ On July 8, 2019, Applicant submitted revised construction emission estimates.¹⁵

Motion for Leave to File Additional Data Requests

On July 8, 2019, Staff filed a motion seeking leave to present further data requests (Staff's Motion).¹⁶ The Committee Scheduling Order set May 6, 2019, as the last day to file data requests.¹⁷ Staff's request is based on the recent changes to the project description described above.

When motions are filed, parties have 14 days to respond in writing, unless the presiding member establishes another schedule.¹⁸ In order to consider this issue at the Status Conference, the Committee orders that any responses to the motion be included in the updated status reports as described below.

PURPOSE OF THE STATUS CONFERENCE

The purpose of this Status Conference is to allow the Committee to evaluate whether the case is progressing satisfactorily and to discuss any potential schedule delays or other relevant matters. The Committee may modify the schedule at any time upon either its own motion or that of a party.¹⁹

ORDER REGARDING UPDATED STATUS REPORTS

The parties are required to file status reports including information about current case development and any new or proposed schedules. The status reports may also include any other relevant matters. Any party wishing to respond to Staff's Motion shall include any such response in its status report.

Staff and Applicant shall, and other parties may, file status reports **no later than July 18, 2019**.

The Energy Commission invites members of the public and other interested parties to participate either on an informal basis or by intervening in the proceeding. Both types of participation allow written and oral comments. At the informal participation level, written and oral comments are considered by the Committee and are part of the record, but are not part of the evidence upon which the Energy Commission can base its decision. The Energy Commission must base its decision on the formal evidentiary record. Intervenors have the right to introduce evidence into the evidentiary record and cross-examine the other parties' witnesses.
