NOTICE OF RECEIPT PETITION FOR CHANGE OF OPERATIONAL CONTROL for the CALPEAK BORDER PROJECT (01-EP-14C)

On July 2, 2019, a petition was filed and docketed with the California Energy Commission (Energy Commission) requesting to change operational control of the CalPeak Border Project. The 49.5-megawatt, simple-cycle, natural gas-fired peaking plant was certified by the Energy Commission on July 11, 2001 with an on-line date of November 7, 2001. Energy Commission action was taken pursuant to Executive Orders D-26-01 and D-28-01 to help avoid or reduce blackouts and other adverse consequences of the energy supply emergency in the state. The facility is located in the city of San Diego.

The petition is requesting to change operational control of the facility from NAES back to the project owner, CalPeak Power-Border, LLC. In addition, the petition notes that the project name will change from "CalPeak Border Project" to "Border Project". Energy Commission staff will review the petition and any comments received to determine whether to issue a staff approval under Title 20, California Code of Regulations, section 1769(b)(2).
