Notice of Intent to Adopt a Negative Declaration for General Service Lamps Appliance Efficiency Rulemaking

Docket No. 19-AAER-04

Project Description and Location

The California Energy Commission (CEC) is proposing statewide regulations to incorporate a revised definition for general service lamps (GSLs) and other supplemental definitions from U.S. Department of Energy (DOE) final rules published on January 19, 2017,¹ align existing test procedures with new and updated DOE test procedures, and reinstate a severability clause into the regulations. The proposed regulations incorporate the federal minimum 45 lumen-per-watt (lpw) efficiency standard for general service lamps that exists in federal law and also incorporate it as a state regulation that is identical to the federal law to ensure implementation of the regulations if repealed at the federal level. California has an exemption from state preemption in U.S. Code, Title 42, Section 6295(i)(6)(A)(vi). For lamps not already covered by California efficiency standards, the proposed regulations and minimum efficacy standard would apply to all general service lamps sold or offered for sale in California on or after January 1, 2020.
