In accordance with the *Orders After July 23, 2019 Status Conference and Revised Scheduling Order* (“Revised Scheduling Order”) docketed on August 16, 2019,¹ MECP1 Santa Clara 1, LLC (the “Applicant”) files this Status Report to inform the Committee on the progress of the Laurelwood Data Center (“LDC”) application for a small power plant exemption (“SPPE”).
