### **Background**

Public Resources Code Section 25301 requires the CEC to prepare an IEPR every two years that includes assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices. The CEC uses these assessments and forecasts to develop energy policies that conserve resources, protect the environment, ensure energy reliability, enhance the state's economy, and protect public health and safety.

Senate Bill 1389 (Bowen and Sher, Chapter 568, Statutes of 2002) directs state government entities to use the information and analyses contained in the adopted *IEPR* to carry out their energy-related duties and responsibilities. During this *IEPR* proceeding, the CEC has coordinated closely with other agencies to ensure consistency in the underlying information used to develop this report.

Vice Chair Janea A. Scott, the IEPR Lead Commissioner, issued a scoping order on March 20, 2019, that identified topics to cover in the report. The CEC held 23 public workshops from January 2019 through October 2019 on topics identified in the scoping order. The *Draft 2019 IEPR* addresses efforts to reduce greenhouse gas emissions and other pollutants from the energy sector while increasing energy equity, ensuring reliability, and controlling costs. The report includes discussion of:

- Changes in the electricity sector
- Building decarbonization and energy efficiency
- Zero-emission vehicles
- Energy equity
- Resiliency of California's energy system to climate change
- Energy reliability in Southern California
- Ten-year forecasts for electricity, natural gas, and transportation demand

After consideration of public comments, the proposed *Final 2019 IEPR* will be released January 2020 to be considered for adoption by the CEC at the February 2020 business meeting.

The purpose of the workshop is to receive public comments on the *Draft 2019 IEPR*. CEC staff will present an overview of the report, followed by an opportunity for public comments.
