**Notice of Availability and Public Comment Period****Docket No. 19-BSTD-10****Application for Approval of AHAM Product Directory  
for use in place of HVI Directory for Kitchen Range Hoods****Purpose**

The California Energy Commission (CEC) has posted this application for approval of an alternative procedure for demonstrating compliance with the 2019 California Energy Code (Energy Code), triggering a mandatory 60-day public review period per California Code of Regulations, Title 24, Part 1, Chapter 10, Sections 10-109 and 10-110. The application from the Association of Home Appliance Manufacturers (AHAM) has been determined to be complete by CEC staff, including all the supporting information necessary to demonstrate the potential use of the AHAM Kitchen Range Hood directory as an equivalent, alternative method of demonstrating compliance with Part 6 where use of the Home Ventilating Institute (HVI) Kitchen Range Hood directory is required.

The CEC seeks public comments on whether AHAM's program and directory provides an identical demonstration of compliance with American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) ventilation standards as provided by the HVI certification program and associated directory. In particular, the CEC is interested in public feedback on whether use of the AHAM directory should be allowed as an alternative source of product performance data where verification to an HVI directory listing would otherwise be required.

**Background**

HVI maintains directories of ventilation products and equipment as a part of their Certified Rating Programs. ASHRAE 62.2, *Ventilation and Acceptable Indoor Air Quality in Low-Rise Residential Buildings*, directs that product performance for kitchen range hoods be verified using the associated HVI directory, in part because the HVI directory has historically been the sole publicly available source for the product data needed for confirming compliance with ASHRAE specifications. The Energy Code incorporates ASHRAE 62.2 by reference, and as a consequence includes identical requirements to verify kitchen range hood product data using the HVI directory.

Provisions in the California Administrative Code (Title 24, Part 1) that pertain to the Energy Code include a provision in Section 10-109 stating that “the Commission may authorize alternative procedures or protocols that demonstrate compliance with Part 6.” AHAM has recently created a product testing and listing program for kitchen range hoods under their Verifide® program, with the goal of providing the same service as is provided by the HVI Certified Rating Program. AHAM is now seeking approval under 10-109 for use of its program and directory for demonstrating compliance with Part 6 where the HVI directory would otherwise be required or specified.
