On October 24, 2019, Mojave Solar LLC (project owner) filed a post certification petition with the California Energy Commission (CEC) for the Mojave Solar Project. The 250-megawatt solar electric generating project was certified by the CEC in August 2006, and began commercial operation in December 2014. The facility is located between Barstow and Kramer Junction, approximately nine miles northwest of Hinkley.

SUMMARY OF PROPOSED CHANGES

The project owner is requesting to construct a new building/staging area to facilitate the operation and maintenance of the facility. This new area would allow the facility to store essential spare parts needed for facility reliability.
