DANNAR, a leader in zero-emission off-road equipment technologies, appreciates the opportunity to provide comments on California Energy Commission's proposed funding concepts for medium- and heavy-duty infrastructure and vehicles within the Clean Transportation Program. DANNAR strongly supports the recent approval of the Investment Plan allocating funds to this sector.

DANNAR has developed a robust off-road battery-electric mobile platform which offers multi-function capabilities that can efficiently replace multiple pieces of single-purpose, conventional diesel off-road equipment currently used by cities/municipalities, universities, amusement parks, ports, freight support facilities, distribution centers, warehouses, intermodal yards, and airports throughout California. The innovative, multi-purpose zero-emission platform, the Mobile Power Station (MPS), can be configured easily work with any manufacturer's work attachments and tools that can lift, grab, push, extract, and haul to allow for flexible use to address daily operations and maintenance.

DANNAR supports staff's proposal to fund infrastructure for medium- and heavy-duty off-road vehicles. Within the proposed concepts, DANNAR's comments include:

1. We respectfully request that the criteria for off-road vehicles be inclusive and allow for a wider range of zero-emission off-road applications. To date, much of the funding at CEC and ARB has primarily been limited funding for ports, airports, and goods movement. Expanding the focus of this funding to be more inclusive will allow for more off-road applications, such as equipment for cites/counties, universities, state fleets, and other end-users. Expanding beyond freight and transit/truck fleets will help increase opportunities to eliminate toxic mobile emissions and exposures, as well as reduce greenhouse gas emissions throughout the state.
