RESOLUTION RE: REVISIONS TO THE GUIDELINES FOR CALIFORNIA'S SOLAR ELECTRIC INCENTIVE PROGRAMS (SENATE BILL 1), SEVENTH EDITION

WHEREAS, Senate Bill 1 (Murray, Statutes of 2006, Chapter 132) (SB 1), as codified in Public Resources Code sections 25780 - 25784 directs the Energy Commission to adopt guidelines to establish eligibility criteria, conditions for incentives, and rating standards for ratepayer-funded solar energy incentive programs, including incentive programs administered by the Energy Commission, the California Public Utilities Commission, and local publicly owned electric utilities; and

WHEREAS, on December 19, 2007, in accordance with Public Resources Code Sections 25780 - 25784, the Energy Commission adopted guidelines entitled, Guidelines for California's Solar Electric Incentive Programs Pursuant to Senate Bill 1 (SB 1 Guidelines), which were most recently revised in 2018; and

WHEREAS, the SB 1 Guidelines require photovoltaic module equipment to be tested by accredited third-party test laboratories; and

WHEREAS, Energy Commission staff, with input from Chair David Hochschild and renewables lead Commissioner Karen Douglas, has proposed revisions to the SB 1 Guidelines due to changes to International Electrotechnical Commission (IEC) third-party laboratory accreditation standards IEC 61215 and IEC 61646 as described in the Notice to Consider Adoption of Revisions to the Guidelines for California's Solar Electric Incentive Programs (Senate Bill 1), Seventh Edition docketed and distributed for public comment on June 28, 2019; and

WHEREAS, the Energy Commission's legal office has considered the application of the California Environmental Quality Act (CEQA) to the adoption of the proposed revisions to the SB 1 Guidelines and concluded that the adoption is exempt from CEQA, because: (1) it is a continuing administrative activity related to general policy and procedure making which is not considered a "project" subject to CEQA under California Code of Regulations, Title 14, Section 15378(b)(2); and (2) if it is considered a project, then it falls under the "common sense exemption" in California Code of Regulations.

Title 14, Section 15061(b)(3) because there is no possibility it may have a significant effect on the environment.

THEREFORE, BE IT RESOLVED, the Energy Commission has considered staff's proposed revisions to the SB 1 Guidelines and finds that its adoption is exempt from CEQA for the reasons stated by the legal office; and

FOOD PRODUCTION INVESTMENT PROGRAM

AMENDMENT TO FOOD PRODUCTION INVESTMENT PROGRAM GUIDELINES

WHEREAS, the Food Production Investment Program, funded by Assembly Bill 109 (Statutes of 2017, Chapter 249) and administered by the California Energy Commission, provides grants to California's food processing industry to reduce greenhouse gas emissions by adopting advanced energy efficiency and renewable energy technologies at California food processing plants, and demonstrating the reliability and effectiveness of these technologies; and

WHEREAS, the Food Production Investment Program Guidelines were adopted by the California Energy Commission at the May 9, 2018 Business Meeting and amended on July 11, 2018; and

WHEREAS, staff proposes an Amendment to the Food Production Investment Program Guidelines (Amendment to FPIP Guidelines) to add budget information, modify award size, add eligible technologies, and clarify the technical scoring criteria. The maximum award size for Tier I projects will increase from \$3 million to \$6 million and low global warming potential refrigerants and waste heat to power are added as eligible technologies for Tier I.

WHEREAS, the California Energy Commission has considered the application of the California Environmental Quality Act (CEQA) to the adoption of the *Amendment to the FPIP Guidelines*, and concludes that the *Amendment to the FPIP Guidelines* is not a project under CEQA. The *Amendment to the FPIP Guidelines* proposes minor modifications and clarifications to the previously approved guidelines and does not have the potential to have a direct physical change or a reasonably foreseeable indirect physical change in the environment.

THEREFORE BE IT RESOLVED, the California Energy Commission hereby finds the adoption of the *Amendment to the FPIP Guidelines* to be not a project under CEQA, adopts the *Amendment to the FPIP Guidelines*, and authorizes the Executive Director or his designee to implement the Food Production Investment Program consistent with the Food Production Investment Program Guidelines as amended.

WHEREAS, the Low-Carbon Fuel Production Program, funded by the Budget Act of 2018, as amended by Senate Bill 856 (Committee on Budget and Fiscal Review, Chapter 30, Statutes of 2018), and administered by the California Energy Commission, provides grants for California's vehicle fuel production industry to reduce greenhouse gas emissions associated with transportation use; and

WHEREAS, funding for the program comes from the California Climate Investments initiative (Greenhouse Gas Reduction Fund) and all funded projects must reduce greenhouse gas emissions and further the purposes of Assembly Bill 32 (Nunez, Chapter 488, Statutes of 2006) and related statutes; and

WHEREAS, the Low-Carbon Fuel Production Program Guidelines (LCFPP Guidelines), developed pursuant to Assembly Bill 109, Senate Bill 856 and Public Resources Code section 25218(e), provide details on how the Energy Commission will administer the program and include information on program design, project selection, and administrative requirements; and

WHEREAS, the development of the *LCFPP Guidelines* has benefitted from a public workshop, meetings with State agencies, and written comments submitted by the public and stakeholders to the docket; and

WHEREAS, after considering all the materials and comments received, Energy Commission staff, with guidance and input from the Lead Commissioner for

Transportation, developed the now-proposed final *LCFPP Guidelines* which set forth the types of projects eligible for funding and administrative requirements; and

WHEREAS, Energy Commission staff will develop solicitations and grants in the ensuing fiscal years to implement the Low-Carbon Fuel Production Program consistent with the *LCFPP Guidelines*; and

ORDER DENYING THE PETITION FOR RULEMAKING HEARING

I. INTRODUCTION AND PROCEDURAL HISTORY

On June 12, 2019, Mr. Steve Uhler (Petitioner) filed a petition with the Executive Director of the California Energy Commission (Energy Commission) requesting that the Energy Commission initiate a rulemaking hearing to amend California Code of Regulations, title 20, section 1208, to allow a member of the public to open a docket to receive filed documents.

The Executive Director deemed this petition complete on June 18, 2019.

Staff recommends denying the petition because it is not necessary to amend the regulations to provide the public with authority to create a docket. Creation of a docket is an agency function. In addition, the Energy Commission's current regulations and practice ensure a document filing and docketing process that allows the public to submit documents in all types of proceedings and to petition the Energy Commission. Finally, the Public Adviser is available to assist the public.

On July 15, 2019, the Commission held a hearing to consider the petition.

II. FINDINGS

Based on the record, the Commission finds that:

1) Public Resources Code section 25218 empowers the Commission to adopt any rule

or regulation, or take any action it deems reasonable and necessary to carry out its statutory duty. Thus, the Commission has the authority to initiate a rulemaking, as requested in the petition.

- 2) The creation of a docket is properly the function of the Energy Commission Staff and not the public. Staff typically creates a docket in advance of any public filings into that docket. If members of the public were permitted to create a docket each time they filed a document with the Energy Commission, confusion would result within proceedings regarding the correct docket and Energy Commission documents would become disorganized. The provisions of section 1208 and 1208.1 provide clear directions to the public on the methods of filing documents in existing proceedings, which includes efiling, emailing, and standard mail.
- 3) A docket is not necessary for the public to submit documents or comments to the Energy Commission when there is no proceeding. Generally, when a member of the public is initiating a petition or request for Energy Commission action, the member of the public is directed by the Energy Commission's regulations to submit that filing to the Executive Director.
- 4) The Public Adviser is available to assist the public in submitting documents and participating in proceedings.
- 5) Amendments to the procedures set forth in sections 1208 and 1208.1 are not necessary. The current process for filing documents with the Energy Commission and the supporting regulatory language do not present any issues or barriers that impact the ability for the public to submit documents to the Energy Commission or otherwise participate in proceedings.

III. CONCLUSION AND ORDER

For the reasons stated above, the Petition is hereby DENIED.
