I find the SMUD proposal infringes on the consumers' benefits of an on-site PV system. However, I do recognize the SMUD community solar credit proposal to be attractive in situations where new homes don't have sufficient solar access (i.e., shading); however, I would prefer to see other entities, not just utilities, as financial participants in such community solar projects.
