I recognize SMUD's early start in engendering PV solar in CA, but in the goal of BEST reducing GHG's, acknowledging the need to move MORE quickly to a smarter distributed grid, and making PV solar ownership MORE accessible to more homeowners, I speak against the SMUD proposal to offer community-shared solar credits in lieu of the so-called 'Solar mandate' of Title 24 requiring some degree of PV solar for new homes. I find the SMUD proposal infringes on the consumers' benefits of an on-site PV system. However, I do recognize the SMUD community solar credit proposal to be attractive in situations where new homes don't have sufficient solar access (i.e., shading); however, I would prefer to see other entities, not just utilities, as financial participants in such community solar projects.
