C1-Santa Clara, LLC (C1) in accordance with the Notice of Committee Conference and Order on Hearings (TN 230859), dated November 25, 2019, hereby files its response to Staff's Memorandum Regarding its Issues Identification, Status Report and Proposed Schedule (TN 230994), dated December 4, 2019. C1 has responded to two rounds of data requests and is currently responding to Staff's Data Requests, Set 3, which it received on December 4, 2019. Staff's Data Request, Set 3 focuses on C1's proposed installation of the emergency generator fuel tanks below grade to comply with policies adopted by the Airport Land Use Commission (ALUC). As will be described in the data responses to Set 3, the ALUC has found that the SBGF and SDC uses at the site are consistent with the ALUC Comprehensive Land Use Plan and its policies. C1 will docket responses to Data Request, Set 3 by Monday December 16, 2019.

With the responses to Staff's Data Requests, Set 3, C1 believes the Staff has everything it needs to complete and publish its Initial Study/Mitigated Negative Declaration and would therefore propose that the Committee adopt a schedule with a January 15, 2019 publication date.
