

Pursuant to Senate Bill 350 (de León, Chapter 547, Statutes of 2015), the CEC and the CPUC have established the Disadvantaged Communities Advisory Group. The DACAG advises the two commissions on the effectiveness of programs related to the Clean Energy and Pollution Reduction Act of 2015 (also known as Senate Bill 350) in disadvantaged communities.
