Disadvantaged Communities Advisory Group: Seeking New Member

The California Public Utilities Commission (CPUC) and the California Energy Commission (CEC) are seeking applications from interested persons to fill a seat on the Senate Bill 350 Disadvantaged Communities Advisory Group (DACAG). The DACAG advises the CPUC and the CEC regarding the development, implementation, and impacts of proposed programs related to the Clean Energy and Pollution Reduction Act of 2015 (Senate Bill 350) in disadvantaged communities.

The DACAG is composed of 11 members from or representing disadvantaged communities. Members represent the diverse nature of disadvantaged communities of the state and reflect the rural and urban, cultural and ethnic, and geographic regions of the state. DACAG members are appointed for 2-year terms, and meet in-person at varying locations across the state quarterly, and meeting via teleconference in the months between in-person meetings. Instructions for Applicants:

Any person interested in joining the DACAG should first review [the Disadvantaged Communities Advisory Group Charter](#), as well as the web page cited above and then transmit the following materials to **DAC-AG@cpuc.ca.gov, by March 16, 2020:**

- 1) Resume or curriculum vitae listing or demonstrating your significant industry knowledge, subject matter expertise, and/or experience in a disadvantaged community.
- 2) Letter of interest, not to exceed two pages, that demonstrates your qualifications including: (i) ability and willingness to meaningfully participate and provide thoughtful and actionable input, and (ii) how specifically you hope to contribute to the DACAG. The letter should include the specific geographical location(s) of the disadvantaged community you represent.
- 3) You may also attach letters of support from other parties that describe (i) how you are qualified to serve on the DACAG; and (ii) how specifically, and perhaps uniquely, you could contribute to the DACAG.

Please note that members will be required to file financial disclosures, and may be asked to refrain from participating in DACAG matters in which they have a potential conflict of interest.
