RE: Application for approval of energy standards in 2019 San Francisco Green Building Code

Dear Ms. Drozdowicz,

This package contains materials documenting two local ordinances duly adopted by the City and County of San Francisco which would require certain buildings to be designed and constructed to consume less energy than otherwise allowed by California's Title 24 Part 6 2019 Building Energy Standards. It is submitted in application for approval by the California Energy Commission pursuant to PRC § 25402.1(h)(2) of two local ordinances:

 San Francisco Green Building Code 2019 (SF BOS File #190964): Transmitted to the CEC November 20, 2019 by the Clerk of the San Francisco Board of Supervisors. This ordinance repealed the 2016 Edition of the San Francisco Green Building Code (SFGBC) on December 31, 2019, and enacted the 2019 Edition of SFGBC, effective January 1, 2020.

The purpose of SF BOS File #190964 is to maintain continuity of applicable local requirements. The 2019 Edition of SFGBC is consistent with the 2016 Edition of SFGBC, with updates where necessary due to changes in related California codes and standards.

While the ordinance predominantly consists of green building standards which are now in effect, the ordinance includes four subsections containing provisions related to energy use, itemized in Attachment 1. These energy-related provisions are generally consistent with local requirements previously approved by the CEC on November 9, 2016, with two significant changes:

- The local ordinance approved by the CEC on November 9, 2016 required installation of solar photovoltaics or solar water heating on new non-residential and residential buildings of 10 occupied floors or less. This local ordinance was amended, effective January 1, 2017, to allow for the installation of a living roof (e.g. a vegetated or 'green' roof) in lieu of solar energy systems. The 2019 Edition of SFGBC contains these amendments, e.g. SFGBC 2019 continues to allow living roof as an alternative to installing solar energy systems, except where superseded by Title 24 Part 6 (2019).
- The local ordinance does not regulate installation of solar energy systems on newly constructed low-rise residential buildings, because installation of photovoltaics is required for low-rise residential by Title 24 Part 6 (2019). However, 2019 Edition of SFGBC continues to require

installation of solar photovoltaics, solar hot water, or living roof on newly constructed high-rise residential or commercial buildings of 10 occupied floors or less.

SF BOS File #190964 was adopted in a manner consistent with CCR Title 24 Part 6 § 10-106 and § 10-110 and approval by the CEC is requested and welcomed.

• Ordinance establishing energy performance requirements in certain newly constructed buildings, aka "Electric Preferred" reach code (SF BOS File #190974): Transmitted to your office January 21, 2020 by the Clerk. This ordinance requires newly constructed mixed-fuel buildings to consume less energy than permitted by Title 24, Part 6. The ordinance received final approval by the Mayor on January 17, 2020 and will become operative on February 17, 2020. Enforcement action for failure to comply will not commence prior to California Energy Commission approval. However, requirements are applicable based on date of permit application and the operative dates of local ordinances. Therefore, projects subject to the ordinance are being notified of its provisions.

The San Francisco Planning Department found both ordinances are exempt from the requirements of the California Environmental Quality Act. San Francisco's Green Building Standards will ensure that newly constructed residential and non-residential buildings in the City and County of San Francisco will be designed and constructed to consume no more energy than permitted by Title 24, Part 6, and the City and County of San Francisco remains committed to ensuring local projects comply with all applicable California building standards, including the 2019 Energy Standards and local amendments.
