# **Background**

Assembly Bill 118 (Núñez, Chapter 750, Statutes of 2007), created the Clean Transportation Program (formerly known as the Alternative and Renewable Fuels and Vehicle Technology Program). The statute authorizes the CEC to develop and deploy alternative and renewable fuels and advanced transportation technologies to help attain the state's climate change and clean air goals. Assembly Bill 8 (Perea, Chapter 401, Statutes of 2013) reauthorized the funding program through January 1, 2024.

Staff is developing a grant funding opportunity (GFO) solicitation that will provide \$7.5 million from the Clean Transportation Program funds for BESTFIT innovative charging solutions. The goal of BESTFIT is to find unique, innovative charging solutions and form factors that are the "best fit" for the local built environment, use case, and vehicle, when compared to traditional charging solutions. BESTFIT will fund projects in both the light-duty and MD/HD sectors.
