ORDER REGARDING FILING OF REBUTTAL TESTIMONY

At the Prehearing Conference held Friday, May 29, 2020, the Committee for the above-captioned proceeding¹ and the parties discussed how to file rebuttal testimony related to the questions contained in the Prehearing Conference and Evidentiary Hearings, Scheduling Order, and Further Orders (the May 8 Notice).² Consistent with the memorandum of the Hearing Officer Regarding Submittal of Rebuttal Testimony to Committee Questions filed May 29, 2020,³ shortly after the conclusion of the Prehearing Conference,⁴ the Committee hereby **ORDERS** as follows:

If parties wish to provide rebuttal testimony to the previous filings by Staff or the Applicant responding to the Committee Questions contained in the May 8 Notice, such rebuttal testimony must be provided in writing **no later than Wednesday, June 3, 2020**. Parties who do not file written rebuttal testimony by Wednesday, June 3, 2020 will be precluded from providing oral rebuttal testimony at the evidentiary hearing. Cross-examination will be allowed from all parties regardless of whether they file written rebuttal testimony or

not. Written rebuttal testimony shall specify which party's response and the Transaction Number that is being responding to.
