Subject: Status of the Committee Proposed Decision

On June 5, 2020, the California Energy Commission¹ (CEC) committee² (Committee) designated to conduct proceedings on the application for a small power plant exemption for the Mission College Backup Generating Facility³ filed a revised scheduling order that stated that the Committee would file a proposed decision during the third quarter 2020.⁴

On June 26, 2020, Oppidan Investment Company⁵ (Applicant) filed its post-hearing brief,⁶ in which the Applicant requested the Committee file a proposed decision for consideration at a July business meeting.⁷

The Committee is working expeditiously on completing the proposed decision, and is working toward presenting such decision to the CEC at an August business meeting.
