## COMMENTS OF ROSEVILLE ELECTRIC UTILITY ON THE 15-DAY LANGUAGE MODIFICATION OF REGULATIONS SPECIFYING ENFORCEMENT PROCEDURES FOR THE RENEWABLES PORTFOLIO STANDARD FOR LOCAL PUBLICLY OWNED ELECTRIC UTILITIES

Roseville Electric Utility (Roseville) appreciates the opportunity to provide comments to the California Energy Commission (CEC or Commission) on the 15-Day Language released July 21, 2020, for *Modification of Regulations Specifying Enforcement Procedures for the Renewables Portfolio Standard for Local Publicly Owned Electric Utilities*. Roseville supports many of the changes made in the 15-Day Language, specifically the following:

- Section 3204(d)(2)(H)(3) preserves contractual flexibility for developers and POUs;
- "Continuous" in section 3204(d)(2)(A) has been clarified as referring to the underlying contract term;
- Section 3204(d)(2)(G) has been added to clarify that eligible Portfolio Content Category 3 products shall be classified as long-term.

These changes not only preserve the integrity of the RPS program and advance California's climate change goals, but also shields ratepayers from the burden of paying for higher cost, higher risk new/repowered renewables in California.

Roseville is also encouraged by the changes made to the wording in section 3204(b)(11) ;however, the implementation of Senate Bill (SB) 1110 does not yet appear consistent with the intent of the statute, which is to apply on a yearly basis. Roseville requests the CEC make clarifying changes as described in Roseville's prior comments submitted on June 22 as an administrative change to section 3204 (b)(11).
