



SMART

A simple device to remember the characteristics of an effective performance measure Specific: performance measures need to be as specific as possible Measurable: a performance measurement is only useful if you can actually measure it Achievable: do not set goals that are impossible to achieve Relevant: performance measurements need to be relevant to the organization's mission and the program's strategic objectives Time-based: make sure that performance measures are achieved within a specific period
