# SECOND REVISED NOTICE OF CALIFORNIA ENERGY COMMISSION HEARING TO RECONSIDER MOTION TO REMAND

On September 9, 2020, the California Energy Commission (CEC) conducted a public hearing to consider the Committee Proposed Decision<sup>1</sup> on the application for a small power plant exemption (SPPE) submitted by C1-Santa Clara, LLC (Applicant) for the Sequoia Backup Generating Facility.

After conducting the public hearing on the Committee Proposed Decision, the CEC adopted a motion to remand the proceedings back to the Committee to consider air quality and public health impacts in light of the recent energy emergencies<sup>2</sup> (Motion to Remand).

Pursuant to California Code of Regulations Title 20, section 1203, subdivision (c), the CEC will conduct a hearing to receive comment and to reconsider the Motion to Remand.

**PLEASE TAKE NOTICE** that on <u>November 10, 2020</u>, the CEC will hold a public hearing during the CEC's regularly scheduled Business Meeting to consider whether to affirm, affirm with modifications, or vacate the Motion to Remand.

# **TUESDAY, NOVEMBER 10, 2020**

The Business Meeting begins at 10:00 a.m.

#### REMOTE ACCESS ONLY

The CEC's November 10, 2020 Business Meeting will be held remotely, consistent with Executive Orders N-25-20 and N-29-20 and recommendations from the California Department of Public Health to encourage physical distancing in order to slow the spread of COVID-19. The public and parties will be able to participate consistent with the direction in these Executive Orders.

To participate remotely, please see the instructions below under the section "PARTICIPATING REMOTELY."

Members of the public and the parties to the Sequoia Backup Generating Facility may participate in and offer oral and written comments at the hearing. The CEC also invites the public, agencies, and parties to file written comments on the Motion to Remand in advance of the hearing. For information about how to file comments before the hearing, please see instructions below under "**PROVIDING COMMENT**."

#### **PURPOSE OF CEC HEARING**

The purpose of this hearing is to consider whether the CEC should affirm, affirm with modifications, or vacate the CEC's adoption of the Motion to Remand. The Chair of the CEC has the authority to regulate the conduct of proceedings and hearings, including the power to designate the process for commenting on a matter.<sup>3</sup> The CEC is taking this additional step to reconsider its action on the Motion to Remand because parties and the public were unable to comment on the proposed Motion to Remand.

During the CEC public hearing to consider the Committee Proposed Decision, parties to the proceeding, including CEC staff, the Applicant, and Intervenor Robert Sarvey, presented arguments and comments to the CEC. During the public comment period, both the California Air Resources Board (CARB) and the Bay Area Air Quality Management District (BAAQMD) offered comments on the Committee Proposed Decision. These commenters proposed that the CEC consider additional information about air quality and public health impacts, particularly in light of the recent energy

emergencies.<sup>4</sup> At the conclusion of the public comment period, the CEC adjourned to a properly noticed closed session to deliberate on the Committee Proposed Decision and statements made by the parties and commenters.

Upon returning from the closed session, the CEC adopted a motion to remand the proceedings back to the Committee for further proceedings, citing the new information about energy emergencies and the need to consider additional relevant information on air quality and public health impacts, as suggested by CARB and BAAQMD (Motion to Remand). The CEC did not solicit or receive any additional public comment before considering and voting to adopt the Motion to Remand.

On September 10, 2020, Applicant filed a "Petition for Reconsideration and Appeal of Committee Ruling" (Petition) regarding the Motion to Remand.<sup>5</sup> According to the Applicant's Petition, the Applicant's counsel was muted and not allowed to comment on the Motion to Remand.<sup>6</sup> The CEC is thus reconsidering its action on the Motion to Remand on its own authority and is, at this time, not considering whether the Applicant has established a legal right to its Petition.

The CEC is interested in hearing from the parties, interested government agencies, and the public on whether to affirm, affirm with modifications, or vacate the Motion to Remand. Those in support of affirming the Motion to Remand with modifications are encouraged to suggest proposed language supporting that recommendation.

After receiving comments from the parties, interested government agencies, and the public, the CEC may take any of the following actions:

- 1. Affirm the action on the Motion to Remand:
  - a. Affirm the action on the Motion to Remand without change; or
  - b. Affirm the action on the Motion to Remand but modify the action by providing further direction or conditions on the remand.
- 2. Vacate the action on the Motion to Remand. The CEC could then:
  - a. Adopt the Committee Proposed Decision as previously presented; or
  - b. Adopt the Committee Proposed Decision and consider any errata or other modifications to it; or

- Set a date for a continued hearing on the Committee Proposed Decision;
   or
- d. Not adopt the Committee Proposed Decision and deny the SPPE.

Until the hearing on the reconsideration of the Motion to Remand is complete, the decision to remand continues in full force and effect. The Committee may issue questions for the parties and government agencies to address in advance of the Business Meeting to assist in the orderly conduct of the hearing.

### **PROVIDING COMMENT**

The parties, state and local government agencies, and members of the public, are invited to submit written comments on the Motion to Remand in advance of the November 10, 2020, Business Meeting. The CEC requests that comments on the Motion to Remand be submitted by 5:00 p.m. on October 30, 2020. It is not necessary to be an Intervenor to participate in the public process.
