The California Energy Commission (CEC) will conduct a pre-rulemaking workshop to discuss and seek comments from interested parties regarding energy data collection to support implementation of Senate Bill 350 (SB 350, de León, Chapter 547, Statutes of 2015) and to improve California energy analytics.

A quorum of commissioners may participate, but no votes will be taken.

The workshop will be held remotely, consistent with Executive Orders N-25-20 and N-29-20 and the recommendations from the California Department of Public Health to encourage physical distancing to slow the spread of COVID-19. The public can participate in the workshop consistent with the direction in these Executive Orders. Instructions for remote participation via Zoom are below.

## **Agenda**

During this workshop, staff will present updated draft regulatory language related to the CEC's implementation of energy supply and demand forecasting under SB 350 and existing law. Staff will provide information on seven different regulation subject areas covering:

- 1) Electric Vehicle System Equipment (EVSE)
- 2) Natural gas system storage
- 3) Hydrogen, biodiesel, and renewable diesel production
- 4) Property Assessed Clean Energy (PACE) programs
- 5) CCR §1353 modifications
- 6) CCR §1304 wind and water electric generation changes
- 7) General regulation language updates

Additionally, staff will seek to improve regulatory language by discussing specific topic areas identified in oral and written comments.

## **Background**

The CEC is mandated by statute to "conduct assessments and forecasts of all aspects of energy industry supply, production, transportation, delivery and distribution, demand, and prices." (Pub. Resources Code § 25301, subd. (a)). These forecasting and assessment activities are developed as part of the Integrated Energy Policy Report (IEPR) that is mandated every two years. (Pub. Resources Code § 25302). To perform this analytical work, the CEC has statutory authority to collect and warehouse data necessary to understand the state's energy usage.

A rapidly changing energy landscape requires the CEC to update its data collection regulations periodically in order to address emerging needs, trends, and technologies. More recently, SB 350 (Chapter 547, de León, Statutes of 2015) codified reducing California's greenhouse gas emissions 40 percent below 1990 levels and two of the state's goals for reducing greenhouse gas emissions: increasing renewable electricity procurement to 50 percent by 2030, and establishing targets that achieve a cumulative doubling of statewide energy savings for all retail natural gas and electricity end-users by 2030. SB 350 also authorized the CEC to adopt data and information submission guidelines that enable the state's efforts to meet those goals. As a result, the CEC adopted an order instituting rulemaking (Order No. 16-0113-05) to develop and implement data collection regulations that support California's energy efficiency, renewable energy, and greenhouse gas reduction policies that combat climate change. This Phase 2 rulemaking effort continues those made under docket number [16-OIR-03](#).


