Tribal Program

Events:

1) Tribal Funding Opportunities Workshop (July 2019)

- 8 tribes represented in person
- 30 people participated virtually with at least 10 representing tribes

2) Sustaining Tribal Resources Conference (July 2019)

- CEC sponsored and Bishop Paiute Tribe hosted in Bishop, California
- 90 persons attended representing 16 tribes and 12 state agencies

3) California Native American Day (Sept 2019)

- Assisted Governor's tribal advisor to plan, organize and implement
- Maintained booth with staff from Tribal Program, EPIC, and PAO

4) California Native American Tribe Leadership Forum (Sept 2019)

Tribal Government Challenge

- \$2.25M funding program for tribes
 - \$250,000 dedicated to gap analysis of tribe status, needs and opportunities
- Partnered with Strategic Growth Council to implement
- Partnered with Office of Planning and Research, Strategic Growth Council and Natural Resources Agency to request full funding for tribal climate change research program to inform 5th Climate Change Assessment.

Currently funding 8 projects serving 10 tribes throughout CA







AB 523 EPIC Investment Requirements Technology Demonstration & Deployment (TDD) Sites









- \$1.5 M funding augmentation to include more HS auto and new truck programs; assess facilities for ASE certification








The Geysers in California


