- 3 COMMISSIONER DOUGLAS: All right. So good
- 4 afternoon. This is the Committee Conference for the
- 5 application for a small power plant exemption for the Sequoia
- 6 Backup Generating Facility. I'm Karen Douglas, the presiding
- 7 member of the Committee assigned to conduct proceedings on
- 8 this application. Commissioner Patty Monahan is here today
- 9 and is the associate member of this Committee. We're all
- 10 participating remotely today using Zoom.
- 11 I'd like to first introduce the people in
- 12 attendance today. My advisors Kourtney Vaccaro and Eli
- 13 Harland. Jana Romero, Commissioner Monahan's advisor. Jim
- 14 Bartridge, technical advisor to the commission on siting
- 15 matters. Susan Cochran, the hearing officer for this
- 16 proceeding. And as I said before, Commissioner Patricia
- 17 Monahan. I'd also like to introduce RoseMary Avalos from the
- 18 Pubic Advisors Office.
- 19 At this point I will ask the parties to please
- 20 introduce themselves and their representatives starting with
- 21 the applicant.
- MR. GALATI: Thank you, Commissioner Douglas.
- 23 Scott Galati representing C-1 Santa Clara which is a division
- 24 of CyrusOne.
- I have with me today also as panelists, and they

- 1 can introduce themselves in more detail when they speak. I
- 2 have Robert Jackson who is the executive vice president and
- 3 general counsel of CyrusOne. And John Hatem who is the
- 4 executive vice president and chief operating officer of
- 5 CyrusOne.
- 6 We also have on the phone as an attendee that can
- 7 lend any information should it become necessary our air
- 8 quality consultant Steve Branoff and Sarah Manzano.
- 9 COMMISSIONER DOUGLAS: Super.
- MR. GALATI: Thank you.
- 11 COMMISSIONER DOUGLAS: Thank you, Mr. Galati.
- 12 Staff?
- MR. PAYNE: Hi, everybody. Leonidas Payne, project
- 14 manager for staff. I've also got Joseph Hughes available in
- 15 case there's any technical questions that come up on air
- 16 quality issues. And of course staff counsel Lisa DeCarlo.
- 17 And I'll throw it to her in case she has some additional
- 18 introductions she wants to make.
- 19 MS. DECARLO: Good afternoon. No additional
- 20 introductions. Thank you.
- 21 COMMISSIONER DOUGLAS: All right. Thank you.
- 22 Intervenors. Robert Sarvey.
- MR. SARVEY: Yeah, this is Bob Sarvey, the
- 24 intervenor. Thank you.
- 25 COMMISSIONER DOUGLAS: Thank you.

- 1 How about California Unions for Reliable Energy?
- Okay. Now let me invite any public agencies to
- 3 introduce themselves. Are there are any federal agencies
- 4 that have joined us this afternoon?
- 5 All right. Let's go to state agencies. How about
- 6 the California Air Resources Board?
- 7 MR. ANDREWS: Hi, this is Thomas Andrews with
- 8 California Air Resources Board.
- 9 MS. GRAHAM: Hi, this is Courtney Graham, also with
- 10 CARB.
- 11 COMMISSIONER DOUGLAS: Okay. Let me turn to local
- 12 agencies. Anyone from the Bay Area Air Quality Management
- 13 District?
- 14 Any other federal, state, or local government
- 15 agencies or Native American tribes here with us this
- 16 afternoon?
- 17 All right. Commissioner Monahan, do you have any
- 18 opening remarks you'd like to make?
- 19 COMMISSIONER MONAHAN: No, I don't. I don't.
- 20 Thank you.
- 21 COMMISSIONER DOUGLAS: Absolutely. So I will now
- 22 hand over the conduct of this proceeding to the Hearing
- 23 Officer Susan Cochran.
- Susan, it's all yours.
- MS. COCHRAN: Thank you so much. Good afternoon,

- 1 everyone, thank you for joining us today. As Commissioner
- 2 Douglas indicated, I'm Susan Cochran, the hearing officer
- 3 assigned to assist the Committee in concluding -- in
- 4 conducting the proceedings on the Application for a Small
- 5 Power Plan Exemption, SPPE, for the Sequoia Backup Generating
- 6 Project that I will generically refer to as the project.
- 7 The Committee noticed today's Committee Conference
- 8 on December 4, 2020. Before we proceed with the substance of
- 9 today's conference, I would like to discuss some housekeeping
- 10 issues. Consistent with Governor Newsom's Executive Order
- N-25-20 and N-29-20, the -- and the recommendations from the
- 12 California Department of Health to encourage physical
- 13 distancing to slow the spread of COVID-19, we are conducting
- 14 this Committee Conference remotely using Zoom.
- We have set up this Zoom meeting so that most
- 16 participants will be able to mute and unmute themselves to
- 17 speak and have the option to use the video feature. On Zoom,
- 18 we look for the black bar at the bottom of your Zoom screen
- 19 for your participation options. If you want to be
- 20 recognized, please use the raise hand feature. If you are on
- 21 your phone, press star 9 to raise your hand. If you have
- 22 muted your phone by pressing star 6, please be sure to unmute
- 23 yourself by pressing star 6 again. The raise hand feature
- 24 creates a list of speakers based on the time when your hand
- 25 was raised and we will call on you in that order.

- 1 The general public may speak during the time for
- 2 the public comment toward the end of the conference.
- 3 A court reporter is present today who is taking
- 4 down all of the discussion and who will prepare a transcript
- 5 of what is said. To ensure that we have a complete and
- 6 accurate transcript, I must ask that only one person speak at
- 7 a time. Second, please identify yourself before you speak.
- 8 When you speak for the first time, please say and spell your
- 9 name slowly. Again, for the court reporter's purposes.
- 10 Meeting remotely like this makes it harder for the court
- 11 reporter and for me to identify who is speaking or who wishes
- 12 to be recognized.
- 13 If you run into difficulties -- next slide, please.
- 14 If you run into difficulties, please contact the
- 15 Public Advisor's Office or Zoom's help center. The
- 16 information and contact information is included both in the
- 17 screen currently on -- both in the slide currently on your
- 18 screen as well as in the notice of today's hearing.
- In addition, so that you know, this slide
- 20 presentation will be put into the docket of this proceeding.
- 21 Are there any questions about how to use Zoom for
- 22 today's conference? No raised hands.
- 23 Seeing then --
- MS. DECARLO: Sorry, I apologize.
- MS. COCHRAN: That's okay.

- 1 MS. DECARLO: I just got an e-mail from Drew Bohan,
- 2 our executive director, asking to be promoted to panelist.
- 3 MS. COCHRAN: Okay.
- 4 MS. DECARLO: If that's possible. Thank you.
- 5 MS. COCHRAN: Thank you. I think that is
- 6 happening.
- 7 So at this point, I'm going to turn the meeting
- 8 over to RoseMary Avalos from the Public Advisor's Office. In
- 9 addition to the housekeeping matters I just discussed,
- 10 RoseMary Avalos will discuss how the public can participate
- 11 in the proceeding.
- RoseMary?
- MS. AVALOS: Thank you, Susan.
- Hello, my name is RoseMary Avalos, and I work with
- 15 the Public Advisor's Office performing work for siting
- 16 proceedings. This presentation will provide ways to engage
- 17 and stay updated in the Sequoia proceedings.
- Next slide, please.
- In every public event held by the CEC such as
- 20 today's Committee Conference time, time will be carved out
- 21 specifically for public comment and that is your opportunity
- 22 to speak on record about issues that concern you. Providing
- 23 public comments is your opportunity to participate informally
- 24 as a public member.
- 25 Aside from providing verbal comments during events,

- 1 you can also provide comments in writing to the public
- 2 advisor and she will relate the main points on your behalf.
- 3 You may also submit written comments through our docket
- 4 system and your comments will be included in the record.
- 5 During this time of the COVID-19 pandemic, the CEC
- 6 has converted to using Zoom as its main platform for holding
- 7 events online and provides instructions in its notices on how
- 8 to participate.
- 9 Next slide, please.
- 10 To stay informed, we highly recommend you go to the
- 11 Sequoia Data Center project web page to obtain the most
- 12 current operation about the proceeding. Here's what the web
- 13 page looks like. The red arrow points to the link where you
- 14 can submit electronic comments. The blue arrow points to the
- 15 e-filing link which is the preferred pathway for staff and
- 16 parties to the proceeding to submit material.
- 17 The gold arrow points to the docket log link. The
- 18 document log is a repository for documents filed by parties
- 19 to the proceeding by Staff and for public comments. It's
- 20 where you find all materials submitted for this proceeding.
- 21 The green arrow is a section where you'll sign up
- 22 for the Sequoia Data Center ListServe. Signing up for the
- 23 ListServe is very important, it's a lifeline to the
- 24 proceeding.
- Next slide, please.

- 1 Signing up with the proceeding ListServe is a
- 2 voluntary procedure. We highly recommend it because it is
- 3 the most efficient link to receive the most current
- 4 information about the proceeding including alerts about what
- 5 is happening in the proceeding and notifications about
- 6 materials that has been docketed.
- 7 Next slide, please.
- 8 And we would like to emphasize the next significant
- 9 opportunity where you may want to participate and provide
- 10 public comment.
- Next slide, please.
- 12 If you need assistance with any of the processes,
- 13 contact the Public Advisor's Office. The best way to
- 14 communicate with us during the shelter-in-place period is via
- 15 email at the email provided on this slide.
- 16 Thank you very much.
- Okay. Hand it over to you Hearing Officer Cochran.
- MS. COCHRAN: Thank you so much, RoseMary.
- Moving now to the substance of this Committee
- 20 Conference. This concerns, as Commissioner Douglas said, the
- 21 SPPE for the Sequoia Backup Generating Facility. The
- 22 application for this proceeding was filed by the Applicant on
- 23 August 14, 2019.
- 24 Briefly, the project concerns the installation of
- 25 54 diesel powered backup generators each capable of providing

- 1 up to 2.25 megawatts of power to ensure an uninterruptible
- 2 power supply for the Sequoia Data Center.
- 3 The project is located at 2600 De La Cruz Boulevard
- 4 in Santa Clara, California. The application and many of the
- 5 other documents I will be mentioning today are available in
- 6 the online docketing system used by the Energy Commission.
- 7 Next slide, please.
- 8 As you see on the slide being shown right now, it
- 9 shows you the address where you can look at the docket. In
- 10 addition, you may contact the Public Advisor's Office for
- 11 assistance in looking at documents or obtaining access to
- 12 them.
- The Committee issued its Proposed Decision for the
- 14 project on August 21, 2020. That Committee Proposed Decision
- 15 recommended that based on the hearing record of these
- 16 proceedings, the CEC grant the requested exemption and adopt
- 17 a mitigated negative declaration to address the project's
- 18 potential environmental impacts.
- 19 The CEC conducted a public hearing on the Committee
- 20 Proposed Decision on September 9, 2020. At the September
- 21 20 -- at the September 9, 2020 business meeting, the
- 22 California Air Resources Board, CARB, made oral comments
- 23 concerning the project and its potential air quality impacts.
- 24 The Bay Area Air Quality Management District, which
- 25 I will refer to as Bay Area, also raised concerns about the

- 1 project. The CEC ultimately voted to remand the project to
- 2 the Committee to obtain additional information about CARB's
- 3 and Bay Area's concerns.
- 4 The day after the September 9, 2020 business
- 5 meeting, the CEC learned that the public had been unable to
- 6 comment on the motion to remand. Accordingly, the CEC held a
- 7 second hearing to reconsider the motion to remand on
- 8 November 16, 2020. Between September 9 and September (sic)
- 9 16, 2020, CARB filed written comments providing greater
- 10 particularity about its concerns about the analysis of
- 11 potential air quality impacts in the Committee Proposed
- 12 Decision and its mitigated negative declaration.
- On November 16, 2020, the CEC met to consider
- 14 whether to affirm, affirm with modifications, or vacate the
- 15 motion to remand adopted on September 9. After considering
- 16 CARB's written comments along with the filings and comments
- 17 from the parties and the public, the CEC voted to affirm the
- 18 motion to remand with the following modifications. One, the
- 19 Committee is directed to conduct limited additional
- 20 proceedings to consider those comments raised by CARB and Bay
- 21 Area in this proceeding that addressed one, input assumptions
- 22 regarding NO₂ impacts from routine testing and maintenance;
- 23 and two, direct and cumulative impacts of emergency
- 24 operations of the project's backup generators. The Committee
- 25 may address additional issues that arise during those

- 2 Two, in order to facilitate a timely resolution of
- 3 this matter, the Committee is directed to report on progress
- 4 in this proceeding to the full California Energy Commission
- 5 at the January 2021 Business Meeting.
- Based on the order to remand, the Committee issued
- 7 noticed of today's Committee Conference. In that notice, the
- 8 Committee issued an order that indicates that the Committee
- 9 wishes to resolve the issues raised by CARB and Bay Area
- 10 during the CEC's initial consideration of the proposed
- 11 decision and adoption of the motion to remand. To that end,
- 12 the Committee order directs the parties to address the
- 13 following questions. One, is the Applicant's modeling relied
- 14 on by staff in the ISPMND, Initial Study Proposed Mitigated
- 15 Negative Declaration, adequate for the analysis of NO2 impacts
- 16 from routine testing and maintenance operations. If not,
- 17 describe why the analysis is not adequate and what would cure
- 18 the described inadequacies.
- 19 Two, can scenario modeling be used to bound a range
- 20 of potential impacts from emergency operations? Are there
- 21 other options to assess impacts of emergency operations? If
- 22 so, how long would it take to perform these options?
- The Committee Order also requested that the parties
- 24 meet and confer to determine whether any of the outstanding
- 25 issues identified in the order could be resolved among the

- 1 parties and to identify what issues remain in dispute. The
- 2 Committee requested the parties provide a joint statement, if
- 3 possible. If a joint statement was not possible, then the
- 4 parties could submit individual statements.
- In the order, the Committee also asked CARB and Bay
- 6 Area respectively or jointly to provide any additional
- 7 information or data they deem relevant to resolving the
- 8 outstanding issues identified by the CEC in the order.
- 9 Further, the Committee requested that CARB and Bay Area
- 10 explain the relevance of any such information or data and how
- 11 the Committee should utilize such information or data.
- 12 On December 14, 2020, Applicant and Staff and
- 13 Mr. Sarvey all submitted individual statements. CARB and Bay
- 14 Area submitted a joint recommendation. We appreciate those
- 15 filings. The parties' filings indicate that Applicant,
- 16 Staff, Mr. Sarvey, and CARB met on December 8, 2020 to confer
- 17 about the issues and questions raised by the Committee. Bay
- 18 Area did not participate in the meet and confer session.
- 19 Staff and Applicant also included information that was
- 20 discussed during a scoping meeting for another SPPE, the
- 21 Great Oaks South Backup Generating Facility that I will refer
- 22 to as Great Oaks.
- 23 Based on the filings, the Committee has the
- 24 following remaining questions that we would like to hear from
- 25 the parties and the representatives today as it relates to

- 1 the one-hour NO_2 standard for routine testing and maintenance.
- 2 Based on the discussions with the CARB representative during
- 3 the Great Oaks scoping meeting, both Staff and Applicant
- 4 believe that CARB agrees with Applicant's modeling approach
- 5 as relied upon by Staff and the ISPMND. Therefore the
- 6 Applicant and Staff believe that the modeling already
- 7 contained in the record should be deemed sufficient and no
- 8 additional analysis required.
- 9 Is this an accurate reflection of what the parties'
- 10 positions are as according to Staff and Applicant?
- 11 Applicant? Staff? Ms. DeCarlo?
- MS. DECARLO: Lisa DeCarlo. Yes, that is our
- 13 understanding based on conversations we had in Great Oaks
- 14 South that the Sequoia analysis fully encapsulates the agreed
- 15 upon approach, at least as per the discussion in the Great
- 16 Oaks South scoping meeting.
- MS. COCHRAN: Okay. Thank you for that.
- Does anyone disagree with that?
- 19 MR. GALATI: This is Scott Galati. We agree as
- 20 well that the issues that were discussed in Great Oaks South
- 21 were in detail and in-depth and we believe that the modeling
- 22 that was done in Sequoia meets what was agreed in Great Oaks
- 23 South.
- MS. COCHRAN: Thank you.
- 25 Representatives from CARB, do you agree with

- 1 Applicant's modeling approach for compliance with the one-
- 2 hour NO₂ standard based on what you learned during the Great
- 3 Oaks scoping meeting?
- 4 MR. ANDREWS: Hi, this is Tom Andrews with CARB.
- 5 Some other possible modeling options were discussed
- 6 during the recent Great Oaks South scoping meeting. However,
- 7 these modeling options are less conservative and thus would
- 8 require greater technical justification to ensure that
- 9 ambient air quality public health standards are protected.
- 10 If one of these other modeling options are being
- 11 considered, CARB will be happy to review any modeling
- 12 protocol detailing their approaches that are proposed for
- 13 this evaluation.
- 14 CARB, as we discussed in our October 15, 2020
- 15 filing is -- we do not agree with the approach it's adequate
- 16 that was used by the Applicant. It revise -- this isn't
- 17 specific to the one-hour NO₂ state standard. The Applicant's
- 18 evaluation relied upon by the CEC Staff uses a five-year
- 19 average of the third highest value of the background hourly
- 20 data. We don't think it's appropriate to use a multiyear
- 21 average of the background NO₂ for this evaluation because the
- 22 one-hour California state NO_2 standard is a simple not to
- 23 exceed one-hour average standard.
- 24 For purposes of modeling compliance with the one-
- 25 hour NO_2 state standard, the maximum modeled 102, NO_2 impact

- 1 for the proposed project should be added to the maximum one-
- 2 hour NO₂ background level. As I previously stated while there
- 3 might be some other modeling approaches that can be used,
- 4 these would have to be further evaluated by CARB and the best
- 5 way to do that is in a modeling protocol prepared by the
- 6 Applicant and submitted to CARB for review.
- 7 MS. COCHRAN: Okay. Is there a way for Staff and
- 8 Applicant to provide an explanation of how the modeling
- 9 previously used can address and resolve these concerns from
- 10 CARB's October 15, 2020 written comments? And what would the
- 11 timing of that be?
- MR. GALATI: This is Scott Galati. My
- 13 understanding is the following, Ms. Hearing Officer. The
- 14 Applicant's modeling did do an hourly average. But we
- 15 believe that Staff actually in its analysis did the more
- 16 conservative approach on using the seasonal max to determine
- 17 what the ultimate impacts are. So the question asks whether
- 18 the Applicant's modeling was appropriate for them to rely
- 19 upon which we believe it was but I think that Staff did some
- 20 more conservative I would say evaluation of that modeling.
- 21 And I'll let Staff describe that.
- MR. PAYNE: Susan, this is Leonidas Payne. I just
- 23 saw a chat go up from Joseph's cue asking that Brewster
- 24 Birdsall be promoted and it's possible that he might have a
- 25 comment on this specific modeling-related question. So I'm

- 1 hoping we can make that happen.
- MS. COCHRAN: Please promote Brewster.
- 3 So understand that today's hearing is not to
- 4 actually resolve this, it's to figure out the path forward to
- 5 finish this proceeding to get to a place where we can have a
- 6 committee-proposed decision considered by the Commission
- 7 again. But I do want to -- so that's where my questions are
- 8 focused on, what's the timing going to be? How are we going
- 9 to resolve these issues?
- 10 So I'm being told that Brewster was made a
- 11 panelist. Mr. Birdsall, are you on the call? Or on the
- 12 Zoom?
- MR. BIRDSALL: Can you hear me?
- MS. COCHRAN: Yes. Thank you.
- 15 MR. BIRDSALL: Okay. Thanks, everybody. Maybe I
- 16 will hide my video just so I do not get so distracted.
- I believe that Mr. Andrews commented specific about
- 18 the use of the season hourly dataset which is a -- a
- 19 representation of the background NO₂ concentrations. And
- 20 we -- we do explain this in the initial study that we relied
- 21 on the -- on the Applicant's processing of the seasonal
- 22 hourly background dataset.
- 23 And what that means is that for a typical day in
- 24 every season, we have 24 individual background numbers. And
- 25 that means one background number for every hour of a typical

- 1 day in each of four seasons. So the background is carved up
- 2 into 24 times 4 different background hours. And this
- 3 approach is similar to how applicants have come in with --
- 4 with their treatment of the background information on other
- 5 cases and so we've been using it for other cases as well.
- 6 And my understanding is that when I was listening
- 7 to the Great Oaks South scoping meeting, that ARB in general
- 8 does not object to this treatment of the background
- 9 concentrations. And to get to stay a little bit more in the
- 10 technical weeds for just another moment, Mr. Galati is
- 11 correct that when we received the Applicant's work for the
- 12 modeling of individual one-hour high concentrations, the
- 13 Applicant's work had included a certain amount of averaging.
- 14 And then again this is explained in the initial
- 15 study. What Staff did during our review and what I did was I
- 16 took away the averaging of the project's one-hour NO2 impacts
- 17 that the Applicant had imbedded in its model and I took away
- 18 that averaging to examine the highest instance of NO_2 impacts
- 19 from the facility itself.
- 20 And so I took an approach that is less conservative
- 21 than the Applicant's and I put that result into the initial
- 22 study. And that is -- that is less conservative than the
- 23 Applicant's approach for the project's specific impact. I
- 24 think -- I think to talk about a modeling protocol at this
- 25 point would really turn --

- 1 (Background voice interruption)
- 2 MR. BIRDSALL: Excuse me. To talk about a modeling
- 3 protocol at this point would put the clock way back to the
- 4 beginning.
- 5 So I'll pause here and just say that normally a
- 6 modeling protocol would be the kind of document that would be
- 7 reviewed prior to even submitting an application, let alone
- 8 an application supported by an environmental assessment like
- 9 the one filed in an SPPE case.
- 10 So I'll pause here and see if there are any
- 11 questions.
- MS. COCHRAN: Okay. So turning back to
- 13 Mr. Andrews, having heard the discussion, does that alter
- 14 what you said initially or is your position still the same
- 15 that -- that you want the max one-hour versus the max
- 16 background? Am I understanding that correctly?
- MR. ANDREWS: Yes. That's -- this is Tom Andrews
- 18 with CARB. That's what we want done and we don't think
- 19 that's what's been done to date. And we want that evaluation
- 20 done and the results published.
- 21 And as I said earlier, yes, there are other
- 22 approaches that can be used, but they're less conservative.
- 23 So that needs to have additional level of consideration done
- 24 and reviewed. That's why we are proposing a modeling
- 25 protocol.

- 1 MS. COCHRAN: That's not my line that was -- that
- 2 had the back chat.
- 3 Okay. So I'm not sure -- so is there a way -- what
- 4 is the best way, then, for us to move forward and get this
- 5 technical issue resolved? Is it they -- would a tech panel
- 6 discussion be appropriate?
- 7 Mr. Galati, since you're the Applicant, I'm going
- 8 to look to you for your suggestion first.
- 9 MR. GALATI: If the goal is to get CARB to agree to
- 10 the modeling, I have no idea how long that will take, if that
- 11 is the goal. We certainly had discussions which I thought we
- 12 made progress and I have not heard Mr. Andrews say that he
- 13 would accept modeling that looks at the seasonal max which is
- 14 what I thought we were in agreement at Great Oaks South.
- 15 Otherwise, we've spent a lot of time at Great Oaks South not
- 16 getting anywhere.
- If that is the direction of what workshopping does
- 18 without coming to a conclusion specifically or a
- 19 recommendation to go back to square one and submit a modeling
- 20 protocol, that's not something that can be done anytime soon.
- 21 And so we would prefer if that's what we needed to do, to
- 22 actually go to evidentiary hearing on this point and have you
- 23 listen to the experts describe what's conservative, what's
- 24 not conservative and make a decision rather than go back to
- 25 the drawing board and try to identify exactly what CARB will

- 1 accept.
- I know that doesn't seem very helpful and I
- 3 apologize. I just --
- 4 MS. COCHRAN: No. It --
- 5 MR. GALATI: -- don't see how to get it done.
- 6 MS. COCHRAN: It's understandable. I -- I
- 7 understand as well. But can -- if -- if the Committee were
- 8 interested in using the approach that CARB is suggesting,
- 9 what is the amount of time that would be necessary? Do you
- 10 have even a ballpark?
- I know -- I know because of the season that that's
- 12 delaying things as well. But is there a ballpark for this?
- MR. GALATI: The best ballpark I can give you is
- 14 when we set out to prepare an application, we usually have an
- 15 air quality consultant that takes 12 weeks to go from the
- 16 beginning of the project to an air quality report. And part
- 17 of that is setting up the modeling.
- 18 So let's assume that we could use the modeling
- 19 setup and that CARB's not asking for any of those changes,
- 20 then I imagine that it would be on the order of six to eight
- 21 weeks to review all the testing and modeling with
- 22 reconfiguration of the background. But I would defer to
- 23 Brewster on that. But I don't think it's something that can
- 24 be done very quickly.
- MS. COCHRAN: Okay. Thank you for that.

- 1 Staff, did you wish to be heard on the timing
- 2 question or any of the other issues that we've just talked
- 3 about?
- 4 MS. DECARLO: Lisa DeCarlo for Staff. I'll just
- 5 jump in here and then invite Brewster or Joey or Leonidas to
- 6 jump in as well.
- 7 I don't have anything to add about the timing. I
- 8 would say, though, or request that if the Committee is
- 9 considering further discussions of these issues, that they be
- 10 Committee-led discussions. We feel that that is the only way
- 11 to try and reach some resolution. You know, we've had lots
- 12 of conversations with the agencies and it's very hard to come
- 13 to a concrete conclusion on some of these issues and progress
- 14 forward. So we think that perhaps the Committee's continued
- 15 involvement might help facilitate that.
- MS. COCHRAN: And then additional question for you,
- 17 Ms. DeCarlo and your clients, do you understand exactly what
- 18 CARB wants? That's probably more a question for your tech
- 19 experts but I'll take your answer too, please.
- MS. DECARLO: Well, we understand max is max. We
- 21 don't believe that it represents a realistic analysis of what
- 22 could occur in real life in terms of missions.
- We don't -- we thought we understood what some of
- 24 these alternative approaches could be acceptable to CARB and
- 25 we thought we had agreement that Sequoia met those

- 1 requirements. But now we're hearing that those now need to
- 2 be vetted. So I guess these alternative approaches would
- 3 require further discussion, it seems, from CARB's position.
- 4 MS. COCHRAN: That's fair enough.
- 5 Those are the questions I had about the routine
- 6 testing and maintenance protocols. Does anyone else have
- 7 anything about that issue that they wish to discuss? Routine
- 8 testing and maintenance.
- 9 MR. SARVEY: Hello, this is Bob Sarvey.
- MS. COCHRAN: Please, Mr. Sarvey. I'm so sorry I
- 11 forgot to call on you.
- MS. SARVEY: I'm used to that.
- MS. COCHRAN: No, it's my fault because I can't see
- 14 your name, so it's my fault.
- MR. SARVEY: Well, the existing record contains
- 16 ambient air quality data from 2018 and the analysis performed
- 17 by the ISPMND by adapting only use data up to 2017. Record
- 18 contains the 2018 data being used. Should be used for both
- 19 NO₂ and PM₂ other. And I agree with CARB and still my
- 20 position both proceeding that don't use average for the
- 21 background, use the max for one-hour background.
- 22 This was -- that was always done at every
- 23 proceeding I've been except the (indiscernible) Data Center.
- 24 Suddenly they've changed their way of evaluating one-hour
- 25 (indiscernible). And I don't understand that. I agree with

- 1 CARB (indiscernible) information substitute the background in
- 2 there. Thank you.
- 3 MS. COCHRAN: Thank you, Mr. Sarvey. And I will --
- 4 and again, I apologize for not recognizing you sooner.
- Is -- Applicant, did you want to have the last word
- 6 on routine testing and maintenance?
- 7 MR. GALATI: No, thank you.
- 8 MS. COCHRAN: Okay. So next I wanted to turn to
- 9 the direct and cumulative air quality impacts of emergency
- 10 operations. And based again on the filings submitted by
- 11 Staff, Applicant, Mr. Sarvey, Staff and Applicant appear to
- 12 agree that scenario modeling can be used to identify a range
- 13 of potential impacts that could be associated with emergency
- 14 operations.
- 15 Could Staff or Applicant or anyone who wishes to
- 16 identify the process they propose for determining the
- 17 scenarios to be modeled?
- I know, Mr. Galati, that you had included some
- 19 language in your filing that talked about things in the first
- 20 part of January of next year. And I was wondering if you
- 21 could -- if you could give us a little bit more detail about
- 22 that.
- MR. GALATI: Yeah, I'm happy to do so. Thank you
- 24 very much. This is Scott Galati.
- 25 And again, I just wanted to -- I didn't a chance to

- 1 thank the Committee for actually scheduling this conference
- 2 for us to be heard, we really appreciate that. And we also
- 3 thank the Committee for writing down questions because I
- 4 don't think that we've really understood exactly what we're
- 5 trying to accomplish. So appreciate that, gave us something
- 6 to shoot for.
- 7 It's not surprising that we don't have agreement on
- 8 emergency operations and how to model them. It's not been
- 9 done in the state, there's not a protocol for it. There's
- 10 memos that say not to do it, no district does it. We even
- 11 have another district participate at the Great Oaks South
- 12 really concerned about trying how to do it. So it's not
- 13 surprising that we are having difficulty coming up with the
- 14 assumption for exactly why the Commission has difficulty with
- 15 it to begin with and that is that they're speculative. So
- 16 you can choose assumptions based on what you would like maybe
- 17 the outcome to be.
- 18 So we don't know if further conversations are going
- 19 to get to a point where the CARB, the district, the
- 20 intervenor, and Staff would all agree. We don't even think
- 21 they're fruitful, especially after what we believe has
- 22 happened. I walked out of the Great Oaks South workshop
- 23 thinking we have some way to go forward. I'm not -- not very
- 24 comfortable that we're ever going to get there.
- 25 So we just said we would shortcut it. We'll do a

- 1 modeling analysis, everybody can look at it, and we should go
- 2 to evidentiary hearing on it and you can hear from the
- 3 experts, and we can defend it. But the idea that we're going
- 4 to be able to at this late date in the proceeding and with
- 5 what's difficult to do when we sit down with the agencies,
- 6 including the fact that sometimes the agencies send technical
- 7 people but they can't agree to find the agency and say yes.
- 8 And when they go back, we think what happens is there's a no.
- 9 So I don't think the workshop process, and remember
- $10\,$ I was the one that really wanted the workshop process, I
- 11 don't think the process will be fruitful here. What I think
- 12 we need is Committee direction and Committee decision. So
- 13 what we're planning to do is if we can't resolve this through
- 14 some sort of agreement to change the technology, what we
- 15 would propose is that we file our modeling analysis with a
- 16 clear outline of all the bases of our assumptions and that
- 17 everybody can comment and look at that analysis, we go to
- 18 evidentiary hearing based on it and move forward.
- 19 So what we're trying to do is to get this done as
- 20 quick as possible, we were on the verge of approval and we're
- 21 trying to claw that time back.
- MS. COCHRAN: Mr. Galati, I have a question about
- 23 what you just said. In terms of if you were to -- if we were
- 24 to say prepare your model and submit it and then we'll have
- 25 analysis and discussion and evidentiary hearing on it, how

- 1 long would it take to run the model? How will you inform us
- 2 of the assumptions used in the model or the parameters used
- 3 in that modeling so that everyone has a full and fair
- 4 understanding of how the model was -- the modeling was done?
- 5 Because that seems to be, I think, part of the issues here,
- 6 too, is understanding what the inputs are.
- 7 So can you -- and again, I'm looking for time
- 8 frames.
- 9 MR. GALATI: We think that in early January to mid-
- 10 January we could submit a modeling result report that also
- 11 has all of the bases for the assumptions identified.
- MS. COCHRAN: Okay. And in -- I'd like to, though,
- 13 delay discussing the change of the equipment option,
- 14 that's -- I have that later on. And but we can take it up
- 15 now. But I think I'd like to hear from the other parties
- 16 starting with Staff about this approach of having this
- 17 modeling run and then proceeding to something else versus
- 18 having more of the workshop.
- I understand, Mr. Galati, your concern about having
- 20 decision makers present to make sure that everyone has agreed
- 21 to what -- how we're moving forward. Is that -- that's what
- 22 I think I just heard you say.
- MR. GALATI: I think -- I don't -- unless the
- 24 Commission -- unless the decision makers tell us this is what
- 25 we will do, I don't believe that we'll come to an agreement.

- 1 MS. COCHRAN: Okay.
- 2 MR. GALATI: So for me, I'd rather you just go to
- 3 evidentiary hearing and do exactly that.
- 4 MS. COCHRAN: Okay. Staff, did you have any
- 5 comments on the approach outlined by Mr. Galati?
- MS. DECARLO: Yes. Lisa DeCarlo. Yes, we're in
- 7 agreement with that approach. We have been talking at a high
- 8 level with the agencies and all the parties on what
- 9 parameters could be identified. And we haven't really made
- 10 much progress on pinning down specific details. And so I
- 11 think at this point, it makes sense just to have the
- 12 Applicant do their best what they think is a reasonable
- 13 modeling assumption approach and Staff can review it. We
- 14 might identify other potential scenarios we think should be
- 15 looked at as well, we might not. But I think at this point
- 16 it would be helpful to have an actual applied model to talk
- 17 about.
- MS. COCHRAN: Okay. Thank you for that.
- Mr. Sarvey.
- MR. SARVEY: Yes, thank you. Wanted to say that
- 21 Mr. Galati is incorrect that an emergency modeling is not
- 22 performed by air quality California. And the record contains
- 23 evidence that that can be performed (indiscernible) modeling
- 24 Santa Clara Data Center. In that case they modeled it and
- 25 determined they had to limit the hours of operation.

- 1 One problem has been identified by Staff in
- 2 determining (indiscernible) data center engines would be
- 3 running in emergency operation. And Mr. Galati informed us
- 4 at the meet and confer that generally all generators are
- 5 operating during emergency operations sharing the load of the
- 6 data center and they keep all generators operating in case
- 7 one fails, there's one right there to replace it.
- 8 I believe worse case, Air Quality should
- 9 (indiscernible) this background, since background is
- 10 experienced all (indiscernible) already this year. And these
- 11 engines will likely operate in some sort of power outage or
- 12 ESPS and there's definitely going to be foul air quality.
- 13 But that's my put on. So.
- MS. COCHRAN: Okay. Thank you.
- 15 So we've talked about modeling. My next question,
- 16 then, is what thresholds of significant -- what would be the
- 17 identified threshold of significance that we would apply to
- 18 analyze the results? So it's one thing to have the numbers,
- 19 how then do we determine whether the numbers show a
- 20 significant impact?
- 21 MR. GALATI: This is Scott Galati. I think that as
- 22 I look down the chessboard, we're coming back to no matter
- 23 what happens, we're coming back to how frequently do we
- 24 predict it would happen?
- I don't see a way to come up with a threshold. So

- 1 for example, if you came up with a threshold that said if
- 2 there is one violation over the life of the project during an
- 3 emergency for one hour, that is a significant impact. That
- 4 is likely to be the case whether you modeled Tier 2 operating
- 5 or Tier 4 operating, there's likely an hour where there's a
- 6 violation.
- 7 So you have to ask yourself how likely is there an
- 8 emergency that occurs during that meteorological condition
- 9 that would happen during that hour? No matter what, we get
- 10 down to the frequency of an emergency event and the
- 11 probability of the coinciding with the right conditions to
- 12 make an impact. So I can't -- I don't know what the
- 13 threshold would be. And that's one of the reasons why we've
- 14 been arguing that this is not useful information.
- So I can't answer that question what should the
- 16 threshold be? For my perspective, it should be is this
- 17 occurrence frequent enough that you can predict that these
- 18 impacts will happen? If it is, that's a significant impact.
- 19 If it isn't, it crawls right in the -- in the case law on
- 20 speculative analysis.
- I would point out that the frequent, you know, in
- 22 order to do the probability that emergency operations would
- 23 happen at the right time and under the right circumstances to
- 24 cause an impact, that probability would be much lower than
- 25 the probability than an emergency would happen at all. And

- 1 you've done that analysis.
- 2 MS. COCHRAN: My understanding was that from the
- 3 Great Oaks scoping meeting was that it was going to take the
- 4 numbers from the model and view it through the lens that
- 5 you're talking about, Mr. Galti, that is the probability of
- 6 it all.
- 7 Do -- CARB --
- 8 MR. GALATI: (Indiscernible.)
- 9 MS. COCHRAN: I'm sorry, go ahead.
- MR. GALATI: I apologize, I thought that CARB moved
- 11 off of that already. I thought we had an agreement there and
- 12 I was informed that we do not.
- MS. COCHRAN: Mr. Andrews, are you still online?
- MR. ANDREWS: I am.
- 15 MS. COCHRAN: Could you -- could you speak to this
- 16 issue of emergency operations and the numerical values versus
- 17 the likelihood of an occurrence and where -- where your
- 18 agency is?
- MR. ANDREWS: CARB's Staff position is two part.
- 20 First part, we would like a modeling analysis done looking at
- 21 a range possible operating its scenarios with multi engines
- 22 operating due to these emergency conditions. And do -- and
- 23 that could be based on information supplied by the Applicant
- 24 in terms of expected buildout of their facility. In other
- 25 words, the phased increase of megawatts due to low server

- 1 load increases and then model those results using much of the
- 2 modeling parameters that have already been developed for the
- 3 project to do the modeling to date, come up with ambient
- 4 impacts, and then compare those impacts to relevant
- 5 standards. We believe ambient air quality standards would be
- 6 relevant because we don't know of any legal exemption from
- 7 those standards due to the operation of any type of facility
- 8 for any reason.
- 9 Then it's, you know, the whole discussion of
- 10 probability should be greatly examined in terms of how often
- 11 this may or may not occur. And so that would be the second
- 12 part which is looking at the probability issue. So it's a --
- 13 part one is do the modeling, compare to relative standards,
- 14 those would also include ambient air quality standards,
- 15 publish those results, and then discuss in detail probability
- 16 of this event occurring/not occurring.
- MS. COCHRAN: And Mr. Andrews, do you have an
- 18 understanding of how many violations of AAQS would be a
- 19 significant adverse impact?
- MR. ANDREWS: No, I do not. I'm sorry.
- MS. COCHRAN: It's okay. Is there -- is there --
- 22 is there somewhere else? Is there a CAPCOA document the --
- 23 is there some published standard already or are we being
- 24 tasked with creating our own standard, our own threshold of
- 25 significance here?

- 1 MR. ANDREWS: Well, one could look at just in terms
- 2 of the probability and whether that is significant or not.
- 3 One could look at a variety of documents, one being the
- 4 CAPCOA guidance and the kind of general standard, that is the
- 5 one-hour federal standard which is a statistical probability-
- 6 type standard. And that sort of approach in terms of not
- 7 looking at -- or looking at a percentile of what the impact
- 8 is which is a form of statistical probability could be used
- 9 as one of the guideline documents.
- 10 Another thing that could be looked at is just how
- 11 ambient monitoring data is used to determine attainment,
- 12 nonattainment in certain areas because there's a certain
- 13 probability there that's used that removes some outlier-type
- 14 peak results.
- So anyway, there are some documents around about
- 16 that that could be included in this probability analysis that
- 17 goes to whether or not the results are -- remain to be
- 18 significant or not.
- MS. COCHRAN: Okay. Thank you for that.
- Mr. Sarvey, did --
- 21 COMMISSIONER MONAHAN: Okay. Can I -- can I ask a
- 22 question on that?
- MS. COCHRAN: Yes, please.
- COMMISSIONER MONAHAN: So Mr. Andrews, I'm just, I
- 25 was trying to -- I've listened very carefully to what you

- 1 were saying and I think the specific question of that is
- 2 there guidance that we can use to inform modeling of
- 3 emergency operations? What I heard, and please correct me if
- 4 I got that wrong, is that there are a lot of guidance
- 5 documents but none specific to that question that we would
- 6 indeed be doing for analysis to a self-generating new
- 7 analysis around emergency operations that doesn't currently
- 8 exist.
- 9 MR. ANDREWS: I think -- this is Tom Andrews of
- 10 CARB. I think it is true that there's going to be few
- 11 guideline documents regarding how to do impact analysis for
- 12 emergency operations, I believe that's true. However, there
- 13 will be some. And the very nature of the federal one-hour NO_2
- 14 standard being a probability of something occurring over
- 15 multiple years is a form of looking at the probability that
- 16 these peak impacts that just don't happen that often can kind
- 17 of be mathematically smoothed out.
- 18 And so yes, there's not that much guidance on
- 19 emergency operations, that is correct. But there is some and
- 20 some was referred to in terms of when the federal one-hour NO₂
- 21 standard was developed.
- MS. COCHRAN: And again, looking at the timing,
- 23 we're saying that this is several weeks/months out; is that
- 24 correct? In order, in other words, to get the modeling done
- 25 where everyone agrees for us to determine the threshold of

- 1 significance and then make the analysis available for review
- 2 and hearing.
- 3 Am I -- is -- am I understanding correctly?
- 4 MS. DECARLO: This is Lisa DeCarlo, I'll just jump
- 5 in.
- 6 Yeah, based on conversations we've been continuing
- 7 to have, I really don't see us reaching agreement on
- 8 significance until -- and I --
- 9 MS. COCHRAN: In the modeling?
- MS. DECARLO: And I hate to say that because I do
- 11 think that is putting the cart before the horse. I think we
- 12 really should have an understanding of what should be
- 13 considered significant before we engage in the modeling. But
- 14 that -- that might not be the most expeditious way to handle
- 15 it, this instance, and it might not be feasible in terms of
- 16 getting people to actually commit to an opinion, an expert
- 17 opinion on that.
- MS. COCHRAN: Mr. Andrews, is there a document or
- 19 documents you could point Staff and Applicant to as we work
- 20 through these issues of modeling and thresholds of
- 21 significance that we could rely on to -- to use in making
- 22 this analysis? And is that something that CARB could put in
- 23 the docket for us to all be able to see?
- MR. ANDREWS: This is Tom Andrews. We -- CARB
- 25 would, can certainly try to find those documents and docket

- 1 them. Also I believe that perhaps the CEC Staff has also
- 2 been looking at collecting district guidance documents on
- 3 emergency operations. Some of them may just say not to do
- 4 the modeling at all. But --
- 5 MS. COCHRAN: Uh-huh.
- 6 MR. ANDREWS: -- we can certainly, I think, work
- 7 together and come up with a kind of a clearinghouse of all
- 8 these documents and docket them and do the best we can to
- 9 collect them.
- MS. COCHRAN: Mr. Galati, I see that you've turned
- 11 your camera on, did you wish to speak? You're muted, Scott.
- MR. GALATI: I apologize.
- MS. COCHRAN: No.
- MR. GALATI: Scott Galati. Mr. Hatem from CyrusOne
- 15 would like to speak. Would that be appropriate?
- MS. COCHRAN: Absolutely. Please go ahead.
- MR. HATEM: Thank you, Ms. Cochran.
- Mr. Andrews, I'm just curious, when you guys look
- 19 at this and, you know, we think about this as two parts,
- 20 right, for our diesel engine operations. You know, one is
- 21 obviously we do testing so we'll run one at a time, you know,
- 22 for a very short period of time. And then, you know, two
- 23 days or a week later we've run another one. So that's one
- 24 part of the emission's calculation, obviously.
- 25 But when we think about -- or when you think about

- 1 as CARB, the emergency operation, I mean, you know, from a
- 2 data center operator's perspective, we think of that as the
- 3 utility itself typically is three nines reliable, right?
- 4 And, you know, statistically that means that the utility will
- 5 be down for, you know, about 8.7 hours a year which means we
- 6 would be running on our generators at that point.
- 7 Is that the generalization that you guys would take
- 8 when you think about the modeling of the emissions? Or is
- 9 it, you know, worst case scenario where the utility's been
- 10 down for weeks? I'm just -- I just want to understand -- and
- 11 I appreciate the time, I appreciate all the work that
- 12 everybody's been doing on this. I'm just curious.
- MR. ANDREWS: Yes, this is Tom Andrews with CARB.
- We're mainly, CARB Staff is mainly focused on the
- 15 short-term ambient air quality standards and the short-term
- 16 toxic standards during these emergency events.
- 17 So that's really a one-hour impact for the most
- 18 part. And so this emergency operation evaluation that we're
- 19 discussing is focused on this theoretical hour where multiple
- 20 engines need to operate at one data center. Then it comes
- 21 down to a couple of questions for that hour. How many
- 22 engines running at what load and the duration?
- 23 Almost all of those parameters have been evaluated
- 24 to date for this project because for the various modeling
- 25 that's been done, the emission rate, exhaust parameters for

- 1 the engines at the various operating loads have already been
- 2 evaluated and looked at in the screening modeling. So much
- 3 of that's already there. It's just a matter of for your
- 4 phased expansion of your data center, how many megawatts
- 5 would be needed for this theoretical hour due to your built,
- 6 expected buildout. And that could be less than a hundred
- 7 percent, it's just you get to justify it.
- 8 But then it's just a matter of how many engines to
- 9 run, what load to provide that megawatt. It may not be every
- 10 engine a hundred percent load, it may be several engines at
- 11 75 percent load because such is a better load for them.
- 12 You're more of an expert at that than I and then evaluate
- 13 those short-term impacts associated with that operation.
- MR. HATEM: Okay. I -- Mr. Andrews, I really
- 15 appreciate that. I -- so it's really about -- it's really
- 16 about that long, that one hour, right, and what the positions
- 17 are.
- MR. ANDREWS: Yes. Because the longer term impacts
- 19 have already been evaluated for this project. So it's really
- 20 just short-term impacts.
- MR. HATEM: Understood. Thank you, Mr. Andrews and
- 22 Ms. Cochran for the time.
- MS. COCHRAN: You're very welcome.
- Mr. Sarvey, did you have any comments on the
- 25 discussion that's just been going about thresholds and

- 1 theoretical hours and the modeling analysis for emergency
- 2 operations?
- 3 MR. SARVEY: Yes, I do. Traditionally sees that
- 4 (indiscernible) power plant site participated in considers
- 5 any violation of an ambient air quality standard as a
- 6 significant impact. (Indiscernible.)
- 7 As I stated before back when all of (indiscernible)
- 8 model (indiscernible) Santa Clara Data Center proceeding.
- 9 Look at the Santa Clara Data Center proceeding
- 10 (indiscernible) install (indiscernible) for the modeling
- 11 protocol.
- 12 Mr. Galati stated that the Commission's
- 13 (indiscernible) occurrence operate (indiscernible) analysis
- 14 would SPPE (indiscernible) concluded that emergency operation
- 15 only occur when the facility has a power outage initiated by
- 16 SPPE. (Indiscernible) analysis concluded there were only two
- 17 outages in the last ten years which affected (indiscernible).
- 18 (Indiscernible) information Great Oaks proceeding for the
- 19 period of 11/27/19 through 9/16/20, a period of ten months.
- That ten months over ten data centers experienced
- 21 emergency operation of the generators that were not related
- 22 to the August 14 (indiscernible) rolling blackout events.
- 23 Few of the data centers had multiple episodes. Since there
- 24 are three data centers in Santa Clara, the probability of
- 25 outages is well over 10 percent (indiscernible) for any data

- 1 center.
- 2 Vast conclusion ride upon this Post Decision is
- 3 that there's 1.6 chance of any data center operating
- 4 generators (indiscernible). Thank you.
- 5 MS. COCHRAN: Thank you, Mr. Sarvey.
- I'm about ready to move on to the next topic I have
- 7 and I wanted to make sure that everybody has had their say.
- 8 Is there anyone else who wishes to speak on the emergency
- 9 operation modeling question thresholds of significance, et
- 10 cetera?
- 11 Okay.
- MS. DECARLO: Sorry, I'm always late.
- MS. COCHRAN: No, no, it's okay.
- 14 MS. DECARLO: Not to throw in another wrench but
- 15 just to make sure this is on everyone's radar, and I don't
- 16 know if it bears discussion now but another point to
- 17 consider, too, in the evaluation is whether or not we're
- 18 evaluating impacts at the fence line or at the receptor.
- MS. COCHRAN: Thank you.
- 20 MS. DECARLO: CARB may have a different opinion on
- 21 that, then -- and I'm not sure that staff has a concrete
- 22 opinion at this point. I think we're leaning more towards
- 23 receptor makes more sense when you're looking at actual
- 24 impacts to a human being. But anyway.
- MS. COCHRAN: Mr. Andrews, do you have thoughts

- 1 right now about fence line versus receptor?
- 2 MR. ANDREWS: Well, this is Tom Andrews with CARB.
- 3 We certainly want all receptors analyzed where theoretically
- 4 because this is we're focused on a one-hour impact here for
- 5 this emergency modeling so this is the theoretical hour where
- 6 someone outside the fence line could be exposed. So everyone
- 7 has to be cautious about starting to remove receptors from
- 8 the modeling grid because as you know, typically the modeling
- 9 grid goes from the fence line outward several kilometers in
- 10 all directions. And so I think we have to be very careful
- 11 starting to remove those receptors because there are pits
- 12 access to the public beyond the fence line and that's --
- 13 we're trying to protect public health.
- So I don't think at this point I can really commit
- 15 on whether or not we can just remove fence line receptors.
- 16 So I'm sorry.
- MS. COCHRAN: That's all right. I wasn't looking
- 18 for a commitment, I was just looking for sort of an initial
- 19 reaction. And I think the initial reaction I'm hearing is
- 20 receptors as Ms. DeCarlo said Staff was leaning towards.
- 21 Mr. Galati, I saw that you had your video on for a
- 22 moment. Did you have another comment you wished to make?
- Okay. I'm going to take that as a no.
- 24 So last --
- 25 COMMISSIONER DOUGLAS: Mr. Galati, are you trying

- 1 to speak? You're muted.
- MR. GALATI: Yeah, sorry about that.
- 3 MS. COCHRAN: That's okay.
- 4 MR. GALATI: I promise I won't do it again. I'll
- 5 address an evidentiary hearing, we have a good answer for the
- 6 information that was provided by the Bay Area Air Quality
- 7 Management District that Mr. Sarvey just identified as
- 8 proving that generators run a lot more. Those -- the vast
- 9 majority, if not all, of those reporting for the last year
- 10 were during the emergency heat events covered by the
- 11 governor's executive order. I just couldn't let that stand.
- 12 I don't want the Commissioners to believe that Staff or we
- 13 have underestimated in Silicon Valley power service territory
- 14 what the actual operations of emergency generators have been
- 15 for the last ten years.
- MS. COCHRAN: Okay, thank you for that.
- MR. SARVEY: That expectation --
- 18 UNKNOWN SPEAKER: Hearing Master Cochran --
- MS. COCHRAN: I'm sorry, one at a time. I heard
- 20 Mr. Sarvey first. And then I believe Mr. Andrews, you were
- 21 after that.
- So, yes, Mr. Sarvey, please.
- MR. SARVEY: I did an analysis in fact, it's
- 24 submission it in Great Oaks and I can run by for you real
- 25 quickly. As I said, there's over ten data centers that have

- 1 had events outside the power outage, I can tell you exactly
- 2 what they were if you want me to go through them.
- MS. COCHRAN: No. Mr. Sarvey, again, we're not
- 4 trying to resolve the issues today. What we're trying to do
- 5 is to figure out the path forward to resolving them. And
- 6 so --
- 7 MR. SARVEY: Well, I'll trying -- I'm just trying
- 8 to correct an incorrect statement.
- 9 MS. COCHRAN: Okay. And -- and sorry?
- MR. SARVEY: And so --
- MS. COCHRAN: Go ahead.
- MR. SARVEY: The statement that most the outages
- 13 and (indiscernible) some issue related to the August 14, '16
- 14 events is incorrect. As I said, there's ten data centers
- 15 that actually were impacted outside those day. And some of
- 16 them were significant. Some of them used a lot of diesel
- 17 fuel, one of them used as much as much as 13,700 gallons of
- 18 diesel fuel.
- 19 So I'm not buying this that all these submissions
- 20 backing data centers all ran during August 14, '16. It's
- 21 just not (indiscernible). I looked at the data, I've already
- 22 analyzed it, and I can send you guys the information if you
- 23 want.
- MS. COCHRAN: Okay. And we may call on you for
- 25 that information soon. So thank you for having that ready

- 1 for us.
- 2 And then, Mr. Andrews, I believe I heard you
- 3 wanting to speak.
- 4 MR. ANDREWS: No, it wasn't me. It was --
- 5 MS. COCHRAN: Oh, okay.
- 6 MR. ANDREWS: I did hear a voice but I'm not sure
- 7 who that was.
- 8 MS. COCHRAN: Okay. There is a voice. Who was the
- 9 voice? Is there someone who wished to speak?
- 10 MR. BOHAN: Drew Bohan (indiscernible) speak up.
- 11 MS. COCHRAN: Thank you, Mr. Bohan. Please, go
- 12 ahead.
- MR. BOHAN: Are you getting an echo in here? An
- 14 echo.
- MS. COCHRAN: I have no echo.
- MR. BOHAN: Okay. I'll just proceed. I just
- 17 wanted to raise sort of a practical concern and that is if we
- 18 were going to do some sort of modeling, I think we would
- 19 benefit from some direction. Ordinarily we look at -- we
- 20 have some sort of target in mind of what in this case a
- 21 significance threshold would be. I understand there may be a
- 22 few options out there that we could select from, but I think
- 23 we should know what the target is in advance, that way we
- 24 would know how to measure the results against that to see if
- 25 there's been significant impact.

- 1 So I'm confused on that and we might benefit from
- 2 CARB's take. Their submission earlier this week suggested
- 3 that if the Applicant were to move to Tier 3 -- or Tier 4,
- 4 excuse me, then there will be no need for modeling. Tier 2,
- 5 we do need to model. But if we don't know the threshold
- 6 significance, I'm confused about how that distinction is
- 7 drawn.
- 8 MS. COCHRAN: Okay. It's interesting, you set me
- 9 up for my next topic which was to discuss the Tier 4
- 10 recommendation made by CARB and BAAQMD. And so let me set
- 11 that up and we can have that discussion.
- 12 It might then resolve your question, Mr. Bohan, is
- 13 that acceptable?
- MR. BOHAN: Certainly.
- MS. COCHRAN: Okay. So as Mr. Bohan said, earlier
- 16 this week, CARB -- yes, earlier this week CARB and BAAQMD
- 17 filed a joint recommendation. As by of background, in its
- 18 initial filing on October 15, 2020, CARB indicated that the
- 19 results of testing of routine -- that the results of testing
- 20 for routine testing and maintenance indicates that both
- 21 routine testing and maintenance and emergency operations
- 22 could result in a potentially significant impact on air
- 23 quality.
- 24 Based on that conclusion, CARB then indicated that
- 25 the Commission should both conduct additional modeling as

- 1 well as analyze whether Tier 4 engines would reduce the
- 2 impacts from the project. In the joint recommendation filed
- 3 on Monday, CARB and Bay Area suggests that if the Applicant
- 4 agrees to use a Tier 4 engines, no further analysis is
- 5 required.
- 6 My question is, is this an issue of backed or is
- 7 this the recommended -- recommendation based on the
- 8 conclusion that the project would create -- would not create
- 9 a significant impact if it used Tier 4 engines?
- 10 And I'm going to look to CARB to speak to this
- 11 first as this was their recommendation to the Commission.
- 12 So can you talk, Mr. Andrews, about why the
- 13 recommendation and use of Tier 4 engines may resolve the
- 14 analytical gap that was originally identified by CARB?
- MR. ANDREWS: Yeah. This is Tom Andrews. I really
- 16 can't say anything more to what the statement says which is
- 17 the basic idea is that Tier 4 engines reduce the NO_2 , NOx
- 18 emissions, therefore NO_2 emissions to such a degree that we
- 19 just felt that it really wouldn't be necessary to do any more
- 20 further modeling with regard to NO₂ impacts. That's just the
- 21 basic idea. I can't really add to that.
- MS. COCHRAN: Okay. So I'm going to open it up to
- 23 Staff and Applicant and Mr. Sarvey now to -- especially you,
- 24 Applicant, because this affects the project that you have
- 25 proposed to speak to the issue of Tier 4 and how that

- 1 resolves CARB's concerns regarding potential impacts.
- MR. GALATI: Thank you. This is Scott Galati.
- First of all, we do appreciate CARB and the
- 4 District of trying to identify a solution that would
- 5 eliminate the time necessary for modeling and then hopefully
- 6 help expedite the Sequoia project to construction.
- We also appreciate that in the statement, you know,
- $8\,$ CARB and District do acknowledge that emergency operations
- 9 are rare. And while we'd like to be able to have a quick,
- 10 easy solution that gets us the time back that we need, we
- 11 just can't do all Tier 4.
- 12 And we have a proposal -- let me just step back and
- 13 just remind the Commission where we are. We submitted an
- 14 application to the District for Tier 2 engines. We got the
- 15 draft of those permits given to us for review of the
- 16 conditions of which we've all accepted. And then we had an
- 17 evidentiary hearing, a person from the Bay Area testified
- 18 that Tier 2 was backed. And then we had a Proposed Decision
- 19 that found a significant impact, and we've moved forward.
- 20 The Tier 2 engines are being manufactured.
- 21 But we only applied for half of those generator
- 22 permits because the generator permit license -- or I should
- 23 say the authority to construct permit for generators, it has
- 24 a lifespan of two years before you have to renew it. So the
- 25 way that this data center will be built is the facility is

- 1 built and the generators are added as customers lease out and
- 2 the interior space is built to their custom specification.
- 3 And so we could commit to be able to do Tier 4 for
- 4 the next half of those generators. And the reason why is
- 5 there is a significant amount of permitting delay and design
- 6 that would be necessary to move to Tier 4 engines that we
- 7 couldn't do for the first phase of this project and keep it
- 8 on schedule but we would have time to do for the second
- 9 phase. We believe that, you know, one of the things that is
- 10 necessary for Tier 4 is to have a material, either urea or
- 11 ammonia be used in the injection system that requires a tank.
- 12 You may remember that we are in the Airport Land
- 13 Use Commission special zones and we had to underground the
- 14 diesel tanks. Either way, whatever the solution would be to
- 15 switch the generators and the technology to reduce the NOx,
- 16 we would have to go back to the Airport Land Use Commission,
- 17 we'd have to go back to the fire department. The last time
- 18 we went through that process with diesel generators, it took
- 19 us about five months. So we actually think that going
- 20 forward and being able to put in Tier 4 would take us six to
- 21 eight months or longer to be able to get the approval to do
- 22 so. We can certainly do that for the second half.
- 23 And I'd like, if you'd indulge John Hatem to be
- 24 able to speak from the company's perspective on the timing.
- MS. COCHRAN: Please go ahead, Mr. Hatem.

- 1 MR. HATEM: Thank you very much. And, you know,
- 2 thank you, Scott and thank you, Commissioner Douglas and
- 3 Commissioner Monahan.
- 4 So I'm John Hatem, executive vice president and
- 5 chief operating officer of CyrusOne, the Applicant here for
- 6 the Sequoia project. And first I want to, you know, thank
- 7 everybody and staff for all the time and work that has gone
- 8 into this. Obviously this has been going on for months. And
- 9 we want to make sure that myself and the companies here
- 10 answer all questions, right, and make sure we're aligned.
- 11 We appreciate CARB and Bay Area's openness to not
- 12 require further modeling of the emissions in their joint
- 13 statement and their acknowledgement that emergency operations
- 14 of the generators would be rare. Kind of seconded what Scott
- 15 said.
- We're here today, really, respectively request
- 17 Committee move forward the Sequoia project as expeditiously
- 18 as possible. And we are, you know, more than willing and
- 19 able to employ Tier 4 generators for the phased
- 20 implementation for the second half of the project. And
- 21 employing the Tier 2 generators with diesel particulate
- 22 filters will remove 90 percent of the particulate pollution
- 23 for the first half of the project and we're poised to
- 24 commence right away.
- 25 Scott -- Scott touched on, you know, the

- 1 repermitting process will delay us, you know, six to eight
- 2 months to start this projects. And, you know, the
- 3 implications of adding additional time to our business case
- 4 are dire right now. We purchased this property months ago
- 5 and our business is very unique. The opportunity and the
- 6 markets are very large-scaled deployments from some of the
- 7 largest companies in the world and in California. Without
- 8 entitlements where we sit right now, we're unable to market
- 9 this project due to the uncertainty of the schedule which
- $10\,$ means we can miss these opportunities and miss these
- 11 opportunities forever, so putting the project further at risk
- 12 for CyrusOne.
- So we truly appreciate the openness of everybody,
- 14 you know, CARB and Bay Area, and would really like to
- 15 understand if we can get to the same place with, you know, 50
- 16 percent of those engines being Tier 4 where we could -- we
- 17 could agree on the modeling and, you know, happy to work with
- 18 CARB and the team here on, you know, the hours of operation
- 19 for maintenance and, you know, provide realistic data for
- 20 data centers that we operate all over the world. So we're
- 21 operating over a gigawatt of capacity from a generator
- 22 perspective in various markets.
- So we can provide real world data for, you know,
- 24 when these data centers are actually running on their
- 25 generators and what the loads are. And even talk about the

- 1 customer profiles and what those loads would be for certain
- 2 hours during the day.
- 3 So if we could move forward quickly, you know, we
- 4 will -- we're ready to start immediately. The construction
- 5 team and the development team work for me and, you know,
- 6 we're ready to get 300 people to work down there on the
- 7 construction side and, you know, dozens of full-time
- 8 employees to help Santa Clara and California.
- 9 So we're here and I'm here to answer any questions.
- 10 And thank you.
- 11 MS. COCHRAN: Thank you again, Mr. Hatem.
- Mr. Galati, are you through? Because I have not
- 13 talked to Applicant or Mr. Sarvey yet but I wanted to give
- 14 you a chance if you had further information you wanted to
- 15 share on this issue.
- MR. GALATI: Yes, we could do this one of two ways
- 17 which we think would expedite the project. We could either
- 18 write a proposed design measure and that could be a
- 19 mitigation measure that is imposed by the city when the city
- 20 issues its permit. Or we could write a condition of
- 21 exemption if the Commission was more interested in that.
- 22 What that condition would look like in either form
- 23 would be not only would we commit to do Tier 4, but that we
- 24 would have the city do a CEQA addendum to any modifications
- 25 to the project that needed to be done because of the

- 1 implementation of Tier 4.
- 2 Because of the implementation of the tanks and that
- 3 that would involve us coordinating with the fire department,
- 4 going -- regoing through the what they call the Project
- 5 Clearance Committee. All of the things that we've been doing
- 6 for the last year and a half at the City of Santa Clara, we'd
- 7 commit to doing those things as there were changes. There
- 8 might be some changes to the design, the layout, where the
- 9 generators go, how they sit.
- 10 We might need to order a different family of
- 11 generators, there might be different noise enclosures. And
- 12 in order to make sure that that's covered by CEQA, we would
- 13 built in -- bake into this approval a requirement to get the
- 14 city to do an addendum should those changes, you know, be
- 15 significant enough for an addendum. That way the Commission
- 16 can be assured that that will do that.
- In addition, we would propose Tier 4 to the Bay
- 18 Area for those generators. The timing that we're looking at
- 19 for Commissioners' purposes is probably within the next
- 20 couple of years we would start that process. Again, we
- 21 didn't apply for those generator permits now because they
- 22 could have expired before we actually needed them. That
- 23 gives us the appropriate time without delaying building the
- 24 project and leasing out the first half.
- That's all. Thank you.

- 1 MS. COCHRAN: Thank you.
- 2 COMMISSIONER DOUGLAS: So Hearing Officer Cochran,
- 3 I know you'll --
- 4 MS. COCHRAN: Yeah.
- 5 COMMISSIONER DOUGLAS: -- you'll get there. It
- 6 would be good to hear ARB's thoughts on this one but of
- 7 course go through the parties first if that's the order.
- 8 MS. COCHRAN: I'll take them however you would like
- 9 them, Commissioner Douglas. If you want to hear from CARB,
- 10 let's hear from CARB.
- 11 COMMISSIONER DOUGLAS: That would be helpful.
- MS. COCHRAN: Mr. Andrews.
- 13 MR. ANDREWS: Yes. This is Tom Andrews.
- I think all I could say on this is if the Applicant
- 15 submits the details of this proposal, you know, all we can do
- 16 is run it by my supervisors and CARB would, you know, have a
- 17 response. I really can't say any more than that at this
- 18 time.
- 19 MS. COCHRAN: Okay. Thank you, Mr. Andrews.
- 20 Ms. DeCarlo, on behalf of Staff, do -- does anyone
- 21 from Staff have any comments on this Tier 4?
- 22 And if Mr. Bohan, if you had questions or commentsm
- 23 too, this would be a good time as well.
- MS. DECARLO: Lisa DeCarlo, just very quickly.
- 25 We're in favor of any -- anything that moves the project

- 1 forward at this point. We believe our analysis as currently
- 2 presented in the record would support moving forward with a
- 3 hybrid approach as the Applicant suggests. So we'd be in
- 4 favor of that.
- 5 MS. COCHRAN: Okay. Mr. Galati -- I'm sorry,
- 6 Mr. Sarvey, did you have any questions or comments on the
- 7 topic of Tier 4 generators?
- 8 MR. SARVEY: Yes, I do have a comment.
- 9 MS. COCHRAN: Thank you.
- MS. SARVEY: I believe CARB and (indiscernible)
- 11 just for making a good faith effort and speed this proceeding
- 12 along by recommending Tier 4. I believe natural gas engines
- 13 would be a better alternative (indiscernible -- lost
- 14 connection) provided multiple. Since the second set of
- 15 generators has not been approved (indiscernible) and
- 16 coordinating (indiscernible) install natural gas engines
- 17 (indiscernible) few hundred hours of the air district,
- 18 provide the Applicant with capacity payments to make him
- 19 whole. He could use them in demand response of your energy
- 20 problems. At the same time, he would not poison
- 21 (indiscernible) community around the project.
- 22 Perhaps the CEC could coordinate with the CPUC for
- 23 the second phase of generators that have not yet been
- 24 approved by the Air District. Thank you.
- MS. COCHRAN: Thank you, Mr. Sarvey.

- 1 Mr. Bohan, did this resolve your questions that you
- 2 had before we started talking?
- 3 MR. BOHAN: Thank you, Hearing Officer Cochran. I
- 4 wouldn't say resolve them, but I think it was helpful to hear
- 5 what the folks had to say. Thank you.
- 6 MS. COCHRAN: Thank you. So is there any last
- 7 comments anyone wishes to make on Tier 4 engines as a
- 8 substitute? Last call.
- 9 Okay. I'm going to move on, then, to the next
- 10 topic for our discussion. And we've touched on it already
- 11 throughout this conversation and that is schedule.
- 12 So under the order that remanded the DSPP to the
- 13 Committee, the next event currently scheduled is an update to
- 14 the Commission at the January business meeting. This update
- 15 needs to include a schedule as far as the Committee can see.
- 16 That's the primary focus is to make sure that we're making
- 17 forward progress in resolving this case. Because it's been
- 18 pointed out already, this case was ready for actual approval
- 19 of the decision and the granting of the SPPE as recommended.
- 20 Staff and Applicant both agreed that the matter
- 21 could be ready for final Commission action at the
- 22 February 10, 2021 business meeting.
- Given what we heard today, is that still a
- 24 realistic target?
- MR. GALATI: Scott Galati. It depends on whether

- 1 or not we have to have agreement on how to do the modeling
- 2 ahead of time. What we'll do is if the Commission -- if the
- 3 Committee would like, it certainly is possible if the parties
- 4 could agree to the half and half approach, doing Tier 4 on
- 5 the second half.
- What we'll do is we will submit by tomorrow the
- 7 actual language of the condition or series of conditions or
- 8 proposed designed measures we'll probably title them as, if
- 9 the Committee would like, and then parties can comment on
- 10 that.
- 11 Because if that agreement is possible, there's
- 12 no -- there's no doubt we could meet the February business
- 13 meeting. Otherwise, we're going to continue to do the
- 14 modeling anyway to try to get that information to the
- 15 Commission in mid-January.
- MS. COCHRAN: Okay. So --
- 17 COMMISSIONER DOUGLAS: I just have the one follow-
- 18 up question.
- 19 So first of all, Mr. Galati --
- MS. COCHRAN: This is Commissioner Douglas
- 21 speaking.
- 22 COMMISSIONER DOUGLAS: Thank you. First of all,
- 23 Mr. Galati, it would be I think very helpful if you could
- 24 post the proposed condition or however you want to style it
- 25 for comment by the parties.

- 1 And I guess a follow-up question is should there be
- 2 a need for an evidentiary hearing, is the time frame that you
- 3 put forward feasible in your view or does that by necessity
- 4 push it back?
- MR. GALATI: If we have to probably, you know, have
- 6 a lengthy discussion about modeling, I think that February
- 7 becomes more difficult to meet.
- 8 COMMISSIONER DOUGLAS: Okay. Thank you.
- 9 MR. GALATI: With an evidentiary hearing. If we
- 10 did it this way, I think the Commissioners could simply write
- 11 an errata to the Proposed Decision.
- 12 COMMISSIONER DOUGLAS: Uh-huh. All right. Thank
- 13 you.
- MS. COCHRAN: Okay. Thank you for that.
- 15 Does anyone else have any comments on the timing of
- 16 further action in this in terms of the receipt of the
- 17 proposed condition of exemption/mitigation measure. Any of
- 18 the issues about how we are going to resolve the modeling
- 19 both for routine testing and maintenance and emergency ops,
- 20 et cetera?
- 21 Are there any other scheduling proposals?
- Okay. Commissioner Monahan, did you have any other
- 23 questions or comments you wanted to make at this time?
- COMMISSIONER MONAHAN: No, I don't. Thank you.
- MS. COCHRAN: Okay. Thank you.

- I am now going to hand over control of the meeting
- 2 to Ms. Avalos from the Public Advisor's Office to assist in
- 3 running the public comment portion of the meeting.
- 4 MS. AVALOS: Thank you, Susan.
- 5 I'll first call on attendees using the raised hand
- 6 feature on Zoom. Please state your name and affiliation,
- 7 spell your first and last name. Also, do not use a speaker
- 8 phone feature because we may not be able to hear you clearly.
- 9 Okay. And if you on the phone, a reminder that to
- 10 dial star 9 to raise your hand and star 6 to mute and unmute.
- 11 I'm looking at the list for raised hands. I'll
- 12 give it a few more seconds.
- Okay. Seeing that there are no raised hands, I'll
- 14 turn to you, Hearing Officer Cochran.
- 15 MS. COCHRAN: Thank you, Ms. Avalos. I want to
- 16 confirm that the Public Advisor's Office did not receive any
- 17 emails or other requested or written comments.
- MS. AVALOS: That's correct. We have not --
- MS. COCHRAN: Okay.
- MS. AVALOS: -- received any.
- MS. COCHRAN: Thank you, again.
- The Committee will now adjourn to a closed session
- 23 in accordance with California Government Code Section 11126,
- 24 subdivision (c)(3) which allows a state body to hold a closed
- 25 session to deliberate on a decision to be reached in a

- 1 proceeding the state body was required by law to conduct.
- 2 We anticipate we will return from closed session in
- 3 approximately, I'm going to say 60 minutes. Is that
- 4 agreeable with the Committee members?
- 5 COMMISSIONER DOUGLAS: Yes, that's fine.
- 6 MS. COCHRAN: Okay. And I would recommend that the
- 7 parties remain as there may be reportable action coming out
- 8 from the closed session.
- 9 So with that, we are in closed session.
- 10 (Off the record at 1:38 p.m.)
- 11 (On the record at 4:54 p.m.)
- 12 MS. COCHRAN: So we have returned from closed
- 13 session and there is reportable action.
- 14 COMMISSIONER DOUGLAS: Yes. So I will go
- 15 through -- I will go through the comments that we have as the
- 16 Committee.
- 17 Is my video on, Susan?
- MS. COCHRAN: Yes, I can see you.
- 19 COMMISSIONER DOUGLAS: Okay. Well, that's --
- 20 that's good.
- 21 So the Committee had four things that we'd like to
- 22 say after our closed session and we want to thank all the
- 23 parties and the ARB for their participation.
- 24 First of all, we wanted to note that because the
- 25 Bay Area has identified Tier 2 engines as best available

- 1 control technology for this project, the Committee analyzed
- 2 the Tier 2 engines and intends to continue to analyze the
- 3 project as presented with the Tier 2 engines.
- 4 If the Applicant wishes to change its project
- 5 description to include half Tier 4 engines or one or more
- 6 Tier 4 engines, the Committee will of course review that
- 7 proposed change and determine whether additional
- 8 environmental analysis would need to be conducted by the
- 9 Energy Commission. So that's one -- one thing.
- 10 Secondly, the Committee would very much like to
- 11 receive detailed information on why or why not the
- 12 Applicant's modeling of one-hour NO2 impacts from routine
- 13 testing and maintenance and Staff's revisions in fact respond
- 14 to the Air Resource's Boards concerns as contained in the
- 15 October 15, 2020 -- is that the --
- MS. COCHRAN: The submittal.
- 17 COMMISSIONER DOUGLAS: Yeah, submittal and repeated
- 18 today.
- 19 It is likely that we would want to get that
- 20 information in the format of testimony so that we could deal
- 21 with it in an evidentiary hearing.
- The Committee at this point has no plans to itself
- 23 identify a threshold of significance on emergency operations
- 24 or to provide specific guidance to the parties and the Air
- 25 Resources Board on how emergency operations should be

- 1 modeled.
- 2 If the parties believe that such modeling would
- 3 provide useful information, the parties and the Air Resources
- 4 Board are invited to perform such modeling and identify
- 5 thresholds of significant -- the threshold of significance
- 6 that they would propose. And if so, the Committee will
- 7 provide an opportunity to present such analysis at an
- 8 evidentiary hearing.
- 9 Finally, the Committee is interested in receiving
- 10 the additional information regarding the frequency of
- 11 operations of the backup diesel generators at the Applicant's
- 12 facilities either in the event of a power outage or to
- 13 address power quality concerns.
- 14 The Committee will memorialize the foregoing in a
- 15 formal order to be issued next week. And we'll ask the
- 16 parties to provide scheduling proposals for the speedy
- 17 resolution of this proceeding.
- 18 So that's what we've got for you today. Please
- 19 look forward to the order that will be issued by the
- 20 Committee and hopefully this information we're providing
- 21 orally today will assist all of the parties in thinking
- 22 through their next steps and getting to work on the
- 23 information that the Committee has requested.
- 24 So with that, I'll turn this back over to the
- 25 hearing officer to adjourn.
