On February 4, 2021, the Southern California Public Power Authority (SCPPA) filed a post certification petition with the California Energy Commission (CEC) for the Magnolia Power Project (MPP). The 323-megawatt combined-cycle facility was certified by the CEC in March 2003, and began commercial operation in September 2005. The facility is located in the City of Burbank, in Los Angeles County.

 Upgrade the existing MPP combustion system to allow improved combustor turndown and increased operating flexibility to integrate better with intermittent renewable energy resources.
