# PETITION FOR POST CERTIFICATION PROJECT CHANGE HUMBOLDT BAY GENERATING STATION (06-AFC-07C)

On March 17, 2021, Pacific Gas & Electric (PG&E) filed a post-certification petition with the California Energy Commission (CEC) for the Humboldt Bay Generating Station (HBGS). The 163-megawatt facility consisting of ten dual fuel (natural gas and/or #2 diesel) Wartsila 18V50DF 16.3-megawatt (MW) reciprocating engine generator sets and associated equipment was certified by the CEC in September 2008 and began commercial operation in October 2012. The facility is located in the City of Eureka, in Humboldt County, California.

## **SUMMARY OF PROPOSED CHANGES**

This request includes the following changes:

 To amend the CEC Conditions of Certification for the project to allow operations less than 50 percent load, down to three (3) MW per engine to support local operations including "low loading mode" and "black start mode".
