The California Energy Commission (CEC) will host a remote-access public scoping meeting via Zoom on April 9, 2021, starting at 10:00 a.m., to discuss and receive comments on the scope of the environmental impact report (EIR) that CEC staff is preparing under the California Environmental Quality Act (CEQA) for the proposed 2022 update to the Building Energy Efficiency Standards (Energy Code) (Title 24, Part 6). All interested parties, agencies, and members of the public are welcome to participate and comment.

The workshop will be held remotely, consistent with Executive Orders N-25-20 and N-29-20 and the recommendations from the California Department of Public Health, to encourage physical distancing to slow the spread of COVID-19. The public can participate in the workshop consistent with the direction in these executive orders. Instructions for remote participation via Zoom are below.

Agenda

The public scoping meeting will consist of a brief presentation by staff outlining the proposed changes to the 2022 Energy Code—which is the project under CEQA—and the proposed scope of the EIR. An opportunity for questions and public commentary will follow.

Background

The project is the adoption of the 2022 triennial update to the Energy Code, Title 24, Part 6 of California's Building Standards Code, with supporting changes to associated administrative provisions in the Administrative Code (Title 24, Part 1). In reviewing the proposed update to the Energy Code, staff determined that an EIR is warranted under CEQA. On March 18, 2021, the CEC issued a Notice of Preparation of an Environmental Impact Report for the 2022 amendments to the Energy Code (Notice of Preparation), which was filed in the docket for this proceeding. (TN 237212.)

The purpose of an EIR is "to identify the significant effects on the environment of a project, to identify alternatives to the project, and to indicate the manner in which those significant effects can be mitigated or avoided." Accordingly, staff seeks input from responsible and trustee agencies regarding the scope and content of the environmental information the EIR should contain that is germane to each agency's statutory responsibilities in connection with the proposed project. Staff also seeks comments from other stakeholders.

The Notice of Preparation identified areas where discussion of potential impacts is warranted. Staff is preparing an EIR to analyze the potential for environmental effects associated with the proposed 2022 update to the Energy Code.
