## NOTICE OF RECEIPT PETITION FOR POST-CERTIFICATION PROJECT CHANGE SUNRISE POWER PROJECT (98-AFC-04C)

On April 12, 2021, the Sunrise Power Company, LLC (Sunrise) filed a petition for a postcertification project change (Petition to Amend Application TN # 237495) with the California Energy Commission (CEC) for the Sunrise Power Project.

The 585-megawatt (MW) combined-cycle, natural gas project was certified by the CEC in December 2000 and began commercial operation in June 2001. The facility is located at 12857 Sunrise Power Road in Fellows, Kern County, approximately 35 miles southwest of the City of Bakersfield.

## SUMMARY OF PROPOSED CHANGES

The project owner seeks approval of the "Sunrise Power Improvement Project" involving performance upgrades, including a new combustion system with higher gas turbine firing temperatures. The project also involves improved cooling, sealing enhancements, and advanced materials. The improvements would result in improved performance and increased output and efficiency, increasing the output from approximately 585 MW to 635 MW. Specific upgrades include the following:

- Upgraded GE Mark VIe turbine control system incorporating advanced combustion optimization capabilities.
- New turbine section (hot gas path).
- New control system to the combustion turbine generator.
