Dear California Energy Commission,

The CEC has taken an important step forward with the incentives for all electric new construction in the 2022 Title 24 code. The CEC needs to improve Title 24 and ensure that all new buildings are all electric. We know that the electrification of buildings reduces GHG emissions, lowers housing costs, and protects public health. And we also know that gas in homes is a threat to public health, worsens climate change, and makes new construction more expensive.

Over 40 cities in California have already recognized this truth and have adopted building electrification standards for new construction, which represents more than 10% of California's population. Many more cities are poised to adopt similar ordinances in 2021 and beyond.

If we are serious about preventing the worst of climate change and meeting President Biden's Climate Goals, California needs to end its reliance on dangerous and dirty fossil gas, and the CEC needs to publicly support all electric buildings across California in the Title 24 Code cycle.
