Pursuant to CCR, Title 20, Article 2, Section 1342, please accept this letter as SDG&E's Application for an extension of time to submit Demand Forecast Forms 8.1a and 8.1b. In addition to this letter, the request is supported by the attached declaration of Timothy S. Vonder (Attachment A).

SDG&E expects to meet its current due date for submitting IEPR demand forecast forms 1.1a&b, 1.2, 1.3, 1.4, 1.5, 1.6a, 2.1, 2.2, 2.3, 3, and 4 by July 21, 2021 (see Application letter dated June 28, 2021, seeking original extension from June 30, 2021 to July 21, 2021). Forms 8.1a&b are also due by July 21, 2021, but data needed to complete these forms won't be available by the current July 21, 2021 due date. SDGE's sequential process leading to creating the revenue information needed for forms 8.1a&b requires additional supply-side modeling, which requires a final demand forecast as an input to the process. This extra step is the reason SDGE is asking for additional time. SDG&E respectfully requests a twenty-eight-day (28) extension (from July 21, 2021 to August 18, 2021) for submitting forms 8.1a&b for the 2021 IEPR.

SDG&E intends to continue to work diligently to prepare these forms as quickly as possible. We have discussed this matter with CEC forecasting and supply-side staff and

CEC staff believes the extra time will not adversely affect the overall 2021 IEPR schedule.
