# 2022 California Green Building Standards Code July 27, 2021

The California Energy Commission (CEC) will host a Lead Commissioner Hearing led by Commissioner Andrew J. McAllister, the CEC's lead Commissioner on energy efficiency. The purpose of this hearing is to receive public comments on proposed revisions to California Code of Regulations, Title 24, Part 11 and Parts 2, 2.5, 3, 4, and 5. Other commissioners may attend and participate in this hearing. A quorum of commissioners may participate, but no votes will be taken.

This hearing will be held remotely, consistent with Executive Order N-08-21 to continue to help California respond to, recover from, and mitigate the impacts of the COVID-19 pandemic. The public can participate in the hearing consistent with the direction in the executive order. The record for this hearing will be kept open until every person has had an opportunity to provide comment.

The public comment period for the proposed regulations will be held from July 2 through August 16, 2021. Any interested person or their authorized representative may submit written comments to the CEC for consideration on or prior to August 16, 2021. The CEC appreciates receiving written comments at the earliest possible date.

### **Background**

The CEC proposes to update the voluntary energy efficiency provisions of the California Green Building Standards Code (Title 24, Part 11) and provide non-substantive changes to Parts 2, 2.5, 3, 4, and 5. Proposed changes to Parts 2, 2.5, 3, 4, and 5 consist of non-substantive cross-references to the Energy Code made at the request of and coordinated with proposing agencies. The CEC proposes to adopt these amendments for publication in 2022 with an effective date of January 1, 2023.

The CEC began the formal rulemaking on July 2, 2021, with the publication of the Notice of Proposed Action (NOPA) by the Office of Administrative Law.
