Notice to Consider Adoption of Draft Revised Commission Guidelines for the California Schools Healthy Air, Plumbing, and Efficiency Programs

As part of the California Energy Commission's (CEC) August 11, 2021, business meeting, the CEC will consider adoption of the Draft Revised Commission Guidelines for the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Ventilation Program and the CalSHAPE Plumbing Program.

The business meeting will be held remotely, consistent with Executive Order N-08-21 to continue to help California respond to, recover from, and mitigate the impacts of the COVID-19 pandemic. The public can participate in the business meeting consistent with the direction in this Executive Order. There will be opportunities for public comment. Instructions for remote participation and a detailed agenda will be posted prior to the CEC's Business Meeting. Background

The School Energy Efficiency Stimulus Program was enacted by Assembly Bill (AB) 841 (Ting, Chapter 372, Statutes of 2020) and includes two grant programs: the School Reopening Ventilation and Energy Efficiency Verification and Repair Program (CalSHAPE Ventilation Program), and the School Noncompliant Plumbing Fixture and Appliance Program (CalSHAPE Plumbing Program).

The CalSHAPE Ventilation Program provides funding to California schools to assess, maintain, and repair ventilation systems, prioritizing schools in underserved communities as defined by AB 841. The CalSHAPE Plumbing Program provides funding to California schools and state agencies to replace aging and inefficient plumbing fixtures and appliances with water-conserving plumbing fixtures and appliances, also prioritizing schools in underserved communities as defined by AB 841.

The *CalSHAPE Plumbing Program Guidelines* were considered and adopted at the CEC's June 9, 2021, business meeting. The *CalSHAPE Ventilation Program Guidelines* were considered and adopted at the CEC's June 25, 2021, business meeting.

CEC staff evaluated revisions made to Public Utilities Code Section 1601 by AB 137 (Committee on Budget, Chapter 77, Statutes of 2021) and have updated the definition of a "local educational agency" in the *Draft CalSHAPE Ventilation Program Revised Commission Guidelines* and the *Draft CalSHAPE Plumbing Program Revised Commission Guidelines*. The changes to the definition are shown here:

(a) "Local educational agency" means a school district as defined in Section 41302.5 of the Education Code or Code, a charter school that has been granted a charter pursuant to Part 26.8 (commencing with Section 47600) of Division 4 of Title 2 of the Education Code, or a regional occupational center established pursuant to Section 52301 of the Education Code that is operated by a joint powers authority and that has an active career technical education advisory committee pursuant to Section 8070 of the Education Code.

The updates to the guidelines are on pages 4, 7, and 8 of the *Draft CalSHAPE Ventilation Program Revised Commission Guidelines* and on pages 2 and 7 of the *Draft CalSHAPE Plumbing Program Revised Commission Guidelines* and are shown in bold underline/strikethrough format with proposed language appearing in bold underline and proposed deletions appearing in strikethrough.
