This is vital as extreme heat overwhelms our state. With electric heat pump water heaters, we can efficiently heat water with clean energy, reducing pollution and creating a more efficient system as we deal with water scarcity.

The new code makes clean energy the simple, most affordable choice to power our homes. That means cleaner air indoors and out, affordable building costs and energy bills, and cuts to climate pollution. The transition to clean electric heat pumps cannot come soon enough in California and across the country, as record-breaking heat waves in areas with historically cooler climates have left millions of families sweltering in unsafe temperatures.

California's building code update during this code cycle is a groundbreaking step — but much more needs to be done to address climate-warming pollution from fossil fuels. I urge you to vote yes on this meaningful step in the right direction.
