Dear Mr. Douglas,

Pursuant to Section 1769 of the California Energy Commission ("CEC") Siting Regulations, Southern California Edison Company (SCE) hereby submits the attached Petition for a Staff Approved Modification ("Petition") for adding electric vehicle charging stations in the parking lot of Mountainview Generating Station (Mountainview).

Mountainview is an 1110MW Combined Cycle natural gas power plant in Redlands, California. SCE has approximately eighty employees who report to Mountainview, primarily operations and maintenance personnel. To meet the State's clean energy goals by 2045, SCE projects three quarters of light-duty vehicles, two-thirds of medium-duty vehicles and one-third of heavy-duty vehicles will need to be electric by 2045. Vehicle affordability, product diversity and charging infrastructure availability are needed to accelerate adoption to meet 2030 targets and prepare for 2045. To support this change, SCE is rolling out electric vehicle charging infrastructure across our service territory. The addition of chargers at Mountainview is one piece of this broader strategy. The project will ensure plant power generation electrical infrastructure is not impacted by the charging stations. The charging stations will be fed from power that is separately metered from plant power.


