PETITION FOR POST CERTIFICATIONPROJECT CHANGE LOS MEDANOS ENERGY CENTER (98-AFC-01C)

On April 23, 2021, Los Medanos Energy Center (LMEC), LLC (project owner) filed a post-certification petition with the California Energy Commission (CEC) for the Los Medanos Energy Center (LMEC). The project owner is working with ION Clean Energy (ION) to demonstrate, on a pilot scale, its solvent technology to capture carbon dioxide (CO2) from a small portion of flue gas from a single turbine exhaust at LMEC. The 500 megawatt (MW) natural gas fired combined cycle energy facility that includes heat recovery steam turbine generator (HRSG) units, transformers, and water treatment and cooling towers, was certified by the CEC in August 1999 and began commercial operation in October 2001. The facility is located in the City of Pittsburg, in Contra Costa County, California.

SUMMARY OF PROPOSED CHANGES

This request includes the following changes:

- The project owner seeks approval for a petition that would allow the LMEC to supply approximately 0.04 percent of its stack gas via above-ground pipeline to an onsite carbon capture and utilization pilot project. The pilot project would be in operation for approximately 15 months with the equipment removed from the site after the pilot project is completed.
- The CO2 capture pilot project would consist of an 80-foot absorber column, a wet sac cooling unit, chemical delivery tanks, and supporting pumps and diagnostic equipment.
- LMEC is requesting modification of the CEC Condition of Certification AQ-34 to reflect the potential for increased formaldehyde emissions resulting in the CO2 pilot project.

REVIEW PROCESS

This petition is reviewed pursuant to Title 20, California Code of Regulations section 1769. The review process includes an evaluation of the effect the change could have on the environment; the project's compliance with applicable laws, ordinances, regulations, or standards; and whether a change to, addition of, or deletion of any condition of certification is required.

After staff has completed its independent review and analysis of this petition, the assessment will be published for public review and comment. Included in the staff analysis, staff will provide written notice of its intent to either process the proposed changes as a staff-approved project change or schedule it for consideration by the CEC at a regularly scheduled business meeting.
