 Miss Margaret Gordon – concerns about equity in trades / contractors / labor force; Black inclusion in journeyman and apprenticeship programs (e.g., highway reconstruction in Oakland experience); sees need for successful case studies that demonstrates the approach.

  - Shrayas Jatkar (CWDB) responded history of exclusion in building trades; including dispatch; in PUC's authority to pull marginalized people into labor markets; multi craft pre-apprenticeship program increases recruitment and retention of women, minority populations, youth; building trade unions community workforce agreement (CWA) expands on typical PLA frameworks; who and how people are served curriculum + skills

  - For offshore wind is CAISO looking at downscaled regional distribution? Offshore wind can be a once-in-a generation opportunity to reorganize grids, and deliver clean electricity reliability and resilience to coastal disadvantaged communities including Tribes.
    - Scott no, CAISO is not looking at smaller scale, but CEC is looking at studies to focus on this, includes southern Oregon and northern and central California, and is just beginning.
  - How is wildfire risk being addressed in the transmission planning? N-1, N-2 planning.
    - Scott yes, using wildfire data sets and it is being incorporated, and looking for ways to avoid those areas.
  - Mismatch between local NEBs and modeling which is statewide
    - Aleecia yes, state is looking at how to bring together local downscaled data with statewide models; will be an ongoing conversation
    - Vice Chair Gunda disaggregate demand at local level demand scenarios at a level to provide local insight; goals to add value and control costs
