(The "Applicants")

1. Specifically indicate those parts of the record which should be kept confidential.

The Applicants seek confidential designation for site-specific drawings, reports, system descriptions and business records related to the fire protection and suppression systems (the "Confidential Fire Protection Information") for the above-referenced six Geysers Units (the "Projects"). The Confidential Fire Protection Information, including the accompanying attachments, for the Projects should be kept confidential in its entirety. The Confidential Fire Protection Information is set forth in Attachment A of this Application.

2. State the length of time the record should be kept confidential, and provide justification for the length of time.

The Confidential Fire Protection Information should be held confidential for the life of the Projects to protect the information contained therein.

3. Cite and discuss (i) the provisions of the Public Records Act or other law which allow the commission to keep the record confidential and (ii) the public interest in nondisclosure of the record.

The Confidential Fire Protection Information should be kept confidential for the following reasons.

First, the Public Records Act broadly exempts corporate proprietary information, including trade secrets from public disclosure. (Gov't Code §§ 6254.7(d), 6254.15.) Trade secrets include "any formula, plan, ... production data, or compilation of information ..., which is known only to certain individuals within a commercial concern who are using it to fabricate, produce, or compound an article of trade or a service ... and which gives its user an opportunity to obtain a business advantage over competitors who do not know or use it." (Gov't Code §§ 6254.7(d), 6254.15.) The California Civil Code Section 3426.1(d) defines a "trade secret" as follows:

- (d) "Trade secret" means information, including a formula, pattern, compilation, program, device, method, technique, or process, that:
  - Derives independent economic value, actual or potential, from not being generally known to the public

- or to other persons who can obtain economic value from its disclosure or use; and
- (2) Is the subject of efforts that are reasonable under the circumstances to maintain its secrecy.

The Confidential Fire Protection Information contains specific compilations of information related to the specific technologies employed at the Projects, including the design and location of certain fire protection systems, drawings, photographs of the Projects, and other commercially valuable information related to the facility's operations and schematics. Such information constitutes trade secrets as the Applicants use such information for asset protection purposes. The Confidential Fire Protection Information has independent economic value from not being generally known to the public or to the Applicants' competitors.

Second, the Public Record Act provides a specific exclusion from disclosure where "...on the facts of the particular case the public interest served by not disclosing the record clearly outweighs the public interest served by disclosure of the record." (Gov't Code § 6255(a).) In this case, the public interest in protecting the fire protection systems for the facilities arises from preventing possible vandalism, tampering, or other third-party imposed damages (like recent cases involving substations and other energy facilities), which clearly outweighs the public interest in disclosure. The fire protection systems are located on a non-public, secure facility, so there is no public interest in disclosing site-specific information on these systems.

Third, the Public Records Act protects from disclosure "Records, the disclosure of which is exempted or prohibited pursuant to federal or state law, including, but not limited to, provisions of the Evidence Code relating to privilege. (Gov. C. 6254(k).) Therefore, where a record is protected from disclosure under the Freedom of Information Act ("FOIA"), it must be protected from disclosure under the Public Records Act.

California Government Code Section 6254 (ab), in pertinent part, excludes from disclosure, "Critical infrastructure information ["CII"], as defined in Section 131(3) of Title 6 of the United States Code, that is voluntarily submitted to the Office of Emergency Services for use by that office, including the identity of the person who or entity that voluntarily submitted the information.\* \* \*" Both the Department of Homeland Security ("DHS") and the Federal Energy Regulatory Commission ("FERC") have processes for this exemption. Similarly, FERC protects Critical Energy Infrastructure Information ("CEII") through an application for protection from FOIA disclosure.

The Confidential Fire Protection Information is similar to the type of information subject to collection by either DHS or FERC. While there has been no occasion to date for the Applicants to seek CII or CEII designation for the Confidential Fire Protection Information, if either agency were to make such a request, the Applicants would be able to avail themselves of these federal agencies' processes to protect the sensitive fire protection-related information for disclosure under FOIA, which would in turn exempt such information from production under California Government Code Section 6254 (ab).

Fourth, the Public Records Act unambiguously protects from disclosure "Personnel, medical, or similar files, the disclosure of which would constitute an unwarranted invasion of personal privacy." (Gov't Code § 6254(c).) The Confidential Fire Protection Information may contain plant personnel and contractor personnel information for both the existing project owner and the prior project owners (PG&E and SMUD), including specific information regarding plant operators and staff, job performance, and other information typically contained within personnel and similar files. Disclosure of the information would constitute an unwarranted invasion of personal privacy.

4. State whether the information may be disclosed if it is aggregated with other information or masked to conceal certain portions, and if so the degree of aggregation or masking required.

The Applicants considered whether it would be possible to aggregate or mask the information. Given the specific details and circumstances analyzed in the *Confidential Fire Protection Information*, no feasible method of aggregating or masking the information could be identified at this time that would not either disclose the information or render the information provided useless.

5. State whether and how the information is kept confidential by the applicant and whether it has ever been disclosed to a person other than an employee of the applicant, and if so under what circumstances.

The Applicants have not disclosed any of the subject information to anyone other than the California Energy Commission staff and other federal, state, and local governmental entities with regulatory authority over the *Confidential Fire Protection Information*, and the Applicants' employees, attorneys and consultants working on behalf of the Projects. Moreover, this information has not been disclosed to persons employed by, or working for, the Applicants except on a confidential, "need-to-know" basis.






