The *2019 Building Energy Efficiency Standards* (Energy Code) allows a registration provider to use an external digital data source (EDDS) service as an alternative to keyed-in data entry for authorized users of its data registry. The registration provider must apply to the California Energy Commission (CEC) for approval to make use of the service (Title 24, Part 6, Reference Joint Appendix JA7).

ConSol Home Energy Efficiency Rating Services, Inc. (CHEERS), a CEC-approved registration provider, submitted an application to use Archon Energy Solutions Compass EDDS service with its data registry on July 20, 2021.

Section 10-110(b) of the Energy Code requires the CEC to make the application available to all interested parties for review and provide opportunity for public comment. As such, the CEC has published a staff report which serves as a summary of the submitted application pursuant to Section 10-110(b).

CEC staff seeks public comment on the EDDS application to inform staff's review and evaluation of the EDDS application pursuant to California Code of Regulations, Title 20, Section 1674, and Title 24, Part 1, Section 10-110.
