The California Energy Commission (CEC) will host a remote-access workshop to discuss ConSol Home Energy Efficiency Rating Services, Inc. (CHEERS) applications to use external digital data sources (EDDS) as an alternative to keyed-in entry to its data registry.

The workshop will be held remotely, consistent with Assembly Bill 361 (Rivas, Chapter 165, Statutes of 2021) to improve public access to state agency meetings during the COVID-19 pandemic. The public can participate in the meeting consistent with the direction provided below. The CEC aims to begin promptly at the start time posted, and the end time is an estimate based on the agenda proposed. The workshop may end sooner or later than the posted end time depending on various factors.

Agenda

This webinar will include a staff presentation on two EDDS applications submitted by CHEERS. The webinar will provide an overview of the EDDS application requirements and a summary of the submitted EDDS applications.

There will be opportunities for public comment at the hearing or otherwise in writing, as described below.

Background

The 2019 Building Energy Efficiency Standards (Energy Code) allow a registration provider to use an EDDS service as an alternative to keyed-in data entry for authorized users of its data registry. The registration provider must apply to the CEC for approval to use the service (Title 24, Part 6, Reference Joint Appendix JA7). CHEERS, a CEC-approved registration provider, submitted two EDDS applications:

- CHEERS application to use the Energy BOSS EDDS service was submitted on June 16, 2021.
- CHEERS application to use the Archon Energy Solutions Compass EDDS service was submitted on July 20, 2021.

Section 10-110(b) of the Energy Code requires the CEC to make applications available to interested parties for review and provide opportunity for public comment. As such, the CEC has published a staff report for each application, which summarizes the submitted application intended for review and public comment following Section 10-110(b). Under Section 10-110(d) of the Energy Code, the CEC may convene a public workshop to gather additional information from an applicant and other interested parties. This workshop will solicit feedback from stakeholders and members of the public to inform staff's review and evaluation of the EDDS applications under the California Code of Regulations, Title 20, Section 1674, and Title 24, Part 1, Section 10-110.
