California Energy Commission (CEC) staff will host a workshop to discuss the California Schools Healthy Air, Plumbing, and Efficiency (CalSHAPE) Program and solicit feedback on potential changes. A quorum of commissioners may participate, but no votes will be taken.

The workshop will be held remotely, consistent with Governor Newsom's Executive Order N-1-22 to improve and enhance public access to state agency meetings during the COVID-19 pandemic. The public can participate in the workshop consistent with the direction provided below. Please note that the CEC aims to begin promptly at the start time posted and the end time is an estimate based on the agenda proposed. The workshop may end sooner or later than the posted end time depending on various factors.

Agenda

Staff will provide a status update on the CalSHAPE program, present proposals for potential changes to the program guidelines, and solicit feedback from workshop participants on the proposals. The presentation topics will include, but are not limited to:

- Program overview and status update
- Application process
- Eligibility requirements

- Funding categories where funds have been exhausted

Background

AB 841 (Ting, Chapter 372, Statutes of 2020) enacted the School Energy Efficiency Stimulus Program, which is referred to as the CalSHAPE Program, and includes two grant programs: the CalSHAPE Ventilation Program and the CalSHAPE Plumbing Program.

The CalSHAPE Ventilation Program provides funding to California schools to assess, maintain, and repair ventilation systems. The CalSHAPE Plumbing Program provides funding to California schools and state agencies to replace aging and inefficient plumbing fixtures and appliances with water-conserving plumbing fixtures and appliances. Both programs prioritize schools in underserved communities as defined by AB 841. The *CalSHAPE Ventilation Program Revised Commission Guidelines* and *CalSHAPE Plumbing Program Revised Commission Guidelines* were considered and adopted at the CEC's August 11, 2021, business meeting.

The CalSHAPE Program began accepting applications for both the CalSHAPE Ventilation and Plumbing programs in Funding Round One. Prior to the start of Funding Round Two, notices of funding availability for each program will be posted on the [CalSHAPE Program page](https://www.energy.ca.gov/programs-and-topics/programs/california-schools-healthy-air-plumbing-and-efficiency-program), <https://www.energy.ca.gov/programs-and-topics/programs/california-schools-healthy-air-plumbing-and-efficiency-program>, and will provide the funding round application start date and deadline, funding restrictions, total available funds, and a breakdown of funds by funding category and application tier.
